Reason on Non-Responsiveness of Non-Responsive bidders: -

Bidder No. 7/16: Shri Krishna and Company in JV with Tags Projects Pvt. Ltd.

Bidder has not submitted clarification to the NHAI letter dated 30.12.2024. Bidder has been declared Non Responsive due to inadequate proof for following in the form of supporting document, as per clause 4.1

Non-submission of Annex-II "Technical Capacity of the Bidder" as prescribed in RFP.
In case of Lead Member, Non-submission of Annex-V, "Statement of Legal Capacity"
In case of Other Member, Non-submission of Bid capacity on bid due date



In the case of both Members, Non-submission of the bidder "Guidelines of Deptt of Disinvestment" as per the requirement of RFP.
In case of Lead Member, Non-submission of Annex-VIII, "Details of ongoing works".
In case of other Members, Non-submission of the Appendix-III i.e. Power of Attorney which is required as per the RFP requirement.
In case of Other members, Non-submission of the Board Resolution which is required as per the RFP requirement.
Non-submission of Appendix-IV, Power of Attorney for Lead Member of Joint Venture
In the case of the Lead Member, Non-submission of "Certificate regarding Compliance".
Non-submission of self- certification that the item offered meets the local content requirement for "Class – I local Supplier" /" Class – II local Supplier", as the case may be.
Bidder has submitted the Annual Accounts, it has been observed that the Notes to Accounts, which form an integral part of the Financial Statements, are missing for the Financial Years 2019-2020 to 2021-2022. As per the RFP requirements. Bidder needs to submit the complete set of documents for the 5 years preceding the Bid Due Date, including Balance Sheets, Financial Statements, Annual Reports, and Notes to the Financial Statements, all audited by a statutory auditor.
1. In case of both, Bidder has not submitted Undertaking w.r.t. that the bidder is not affiliated to the firm or entity that has been hired or employed by the Employer for preparation of bid documents or to supervise the contract as stated in the Appendix to ITB clause 4.1 (h). Bidder to Clarify.
2. In case of Lead Member, bidder has not submitted an undertaking w.r.t. "On going Projects with Litigation History" and "On going process of Black-Listing". Bidder to Clarify.
3. In case of Lead Member, Bidder has not submitted Undertaking w.r.t. Evidence of availability (either owned or leased or rented) of items of construction and maintenance equipment named in Clause 4.1 j (1).
4. In case of Both, Bidder has not submitted Undertaking w.r.t. Availability of personnel with qualification and experience as stated in the Appendix to ITB clause 4.1 (j) (2).
1. non-submission of proof for all 3 (Three) Mobile Maintenance Unit out of (required no. of three) having Capacity more than 6 tonne
Bidder has submitted document in support of Vibratory Roller, however from the available documents it is not clear that Vibratory Roller having capacity of 8/10 T.
Bidder has submitted document in support of Static Roller (8/10 T), however from the available documents it is not clear that Static Roller having capacity of 8/10 T.
Non-submission of owing proof of Small Roller/Compactor.
Bidder has submitted document in support of Mechanical Broom, however from the available documents it is not clear that Mechanical Broom having capacity of 1250 sqm per hour.
Non-submission of owing proof of Dewatering Pumps (required no. 2)
Non-submission of owing proof Mini hot mix plant (6/10 T/Hr capacity) with indirect heating arrangements
Non-submission of owing proof of String Line Set

Bidder No. 9/16: M/s Murari Lal Agarwal

Bidder has proposed and submitted the CV of Mr. Mohit Sharma for the position of Road Safety Auditor. However, an e-mail had been received where the key personnel stated that, "I am Mohit Sharma Road Safety Auditor cum Traffic & Safety Expert, has given my consent as Road Safety Auditor for Project "Routine Maintenance & Periodic renewal work of 2 lane with paved shoulder/4 lane of Gagaria-BaoriKalan- Serva- Bakhasar Section of NH-925 (Chainage (0+000-136+520)) and Sata-Gandhav Section NH-925A (Chainage (0+000-60+450)) (Total length 196.970km.) in the state of Rajasthan" only to M/s Tan Singh Chauhan. Further it has come to my knowledge that some other contractors has also used my CV for subject work without my knowledge and consent. Therefore, your good office is requested Not to consider my CV other than M/s Tan Singh Chauhan".

In light of this statement by key personnel vide mail, CV of the Road Safety Auditor submitted by the bidder is now rejected or considered as null. Furthermore, Bidder has been declared non-responsive as per clause 4.1 j (2)

Bidder No. 11/16: Ganeshgarhia Construction Private Limited

Bidder has not submitted the required document i.e., Road Safety Audit Certificate from appropriate approved Govt. agency which fails to satisfies the requirement of the clarification sought. Hence, the CV has not been considered and Bidder declared as non-Responsive as per clause 4.1 j (2)

Bidder No. 13/16: Vishnu Prakash R Punglia Limited

Non-submission of the CV for the post of Site Engineer-cum Survey Engineer cum Material Engineer & Incident cum Road Property Manager cum Route Operation Manager meeting the required qualification and experience, including detailed work experience, Project name and Duration of Year.

Bidder No. 15/16: Heera Ram Godara

Non-submission of all 4 required CV for the post of Site Engineer-cum Survey Engineer cum Material Engineer in the Bid. As per clause 4.1 j (2), a lesser number of personnel than required shall make the bid non-responsive.

Bidder No. 16/16: GHV (India) PVT. Ltd

Non-submission of Air compressor (Required 2 nos.) & Dewatering Pumps (Required 2 nos.) in the Bid as required under clause 4.1 (j) (i)

Bidder fails to submitted the Road Safety Audit Certificate from an appropriate and approved government agency for Mr. Abhishek Kumar. Accordingly, Bidder declared non-Responsive as per clause 4.1j (2).
