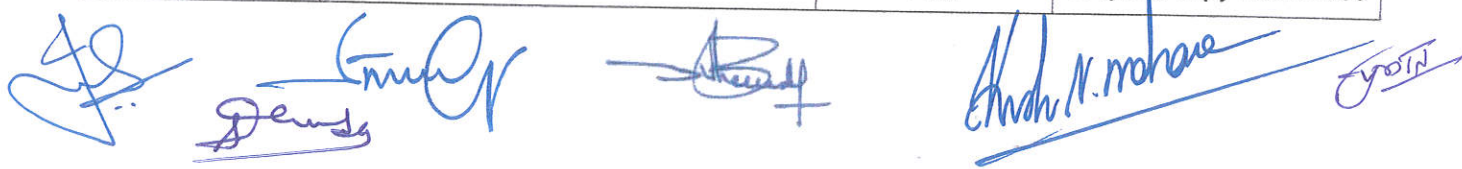

3. Upon repatriation of one of the Tender committee member Shri. V.Nagaraj, DGM (T) cum Project Director, PIU, Dindigul and subsequent taking over by Shri. Sateesh Gandhaamu DGM(T) as Project Director, PIU, Dindigul, a committee has been re constituted with the following members under Office Order dt:19.09.2024 to carry out tender evaluation;

4. As per RFP, last date of submission of e-bids and date of technical bid opening was scheduled on 19.09.2024 up to 16:00 Hrs and 20.09.2024 @ 16:00 Hrs, respectively.
5. The Committee opened the e-bids received through online mode (on 18.09.2024) and decrypted. Totally 5 Nos. of Bids was received through online. Accordingly, the details of Tender Fee (Rs.25,000/-) submitted by the 5 Nos. of bidders were furnished to Accounts Division. In response, Accounts Division has confirmed the receipts of Tender Fee for 5 Nos of bidders. With respect to EMD/Bid security, all the 5 Nos. of bidders have furnished the Hard copies of BG/DD for an amount of Rs.2,81,000/-. 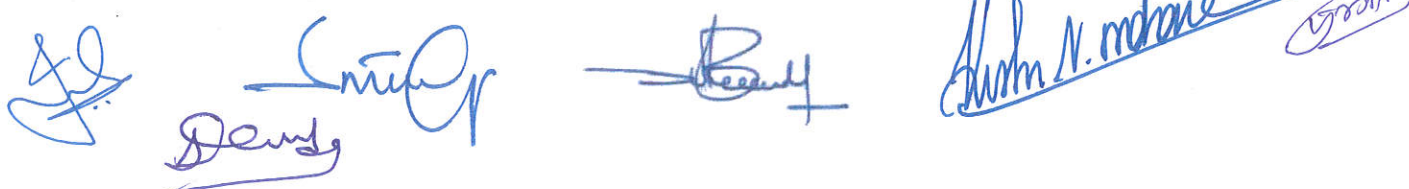
7. The detailed technical evaluation is as follows,

7.1 M/s. Mercury Electrical Corporation :

- The bidder has *furnished* the details for Average Annual Turnover during Last 3 years *duly certified by Chartered accountant*. The average Turnover is Rs.819 Lakhs, which is more than the requirement of Rs.42.09 Lakhs as per RFP.
- The bid capacity worked out to Rs.548.1496 lakhs which is more than bid value of Rs.140.29 Lakhs.
- The Value of work done for the One similar nature of work is Rs.403.82 Lakhs which is more than the requirement of Rs.112.23 Lakhs.
- The Bidder has submitted the details of Power of Attorney as per Section-II, Clause 4.2 (a) & Section-III, Clause 1.
- The bidder has mentioned the details of vehicles as per Appendix to ITB Section-II, Clause 4.4. B (b)(i) and submitted the owned/leased invoice for Excavator cum Loader, Water Tanker (Tractor Trolley/truck mounted), Road Marking Machine, Self-Loading Concrete Mixer (SLCM) or Ready Mix Concrete, Crane 12 MT, Reflectometer, Generator 250 KVA, Vibratory Roller & Plate compactor.
- With respect to staff qualification, as per bid submission, the candidate for Project Manager has 11 years of experience as Project Manager, Site Engineer cum Material engineer has 6 yrs of experience, and Electrical engineers has 7 yrs of experience. Degree certificate for all the 3 candidates have been submitted by Bidder.
- Hence, as the bidder has furnished the requirements as per RFP, the tender evaluation committee recommends to consider the bids as "Responsive".

7.2 M/s. V S Construction:

- The bidder has *furnished* the details for Average Annual Turnover during Last 3 years *duly certified by Chartered accountant*. The average Turnover is Rs.687 Lakhs, which is more than the requirement of Rs.42.09 Lakhs as per RFP.



- The bid capacity worked out to Rs.1173.71 lakhs which is more than bid value of Rs.140.29 Lakhs.
- The Value of work done for one similar nature of work is Rs.569.98 Lakhs which is more than the requirement of Rs.112.23 Lakhs.
- The Bidder has *not furnished the Power of Attorney* (Ref: Section-II, Clause 4.2 (a) & Section-III, Clause 1.2).
- The bidder has mentioned the details of vehicles as per Appendix to ITB Section-II, Clause 4.4. B (b)(i) and submitted the owned/leased invoice for Excavator cum Loader, Water Tanker (Tractor Trolley/truck mounted), Road Marking Machine, Self-Loading Concrete Mixer (SLCM) or Ready Mix Concrete, Crane 12 MT, Reflectometer, Generator 250 KVA, Vibratory Roller & Plate compactor. For Reflectometer confirmation letter from the Original Equipment Manufacturer has been furnished. Hence, the requirement as per RFP is found to be satisfied.
- With respect to staff qualification & as per bid submission, Project Manager has 10 years of experience as a Project Manager, Site engineer cum Material engineer has 5 yrs of experience, and Electrical engineers has 6 yrs of experience. Degree certificate for all the 3 candidates have been submitted by Bidder, which satisfies the requirement as per RFP.
- Hence, due to not meeting the above requirement as per RFP, the tender evaluation committee recommends to consider the bids as **"Non-responsive"**.

7.3 M/s. S Kannan:

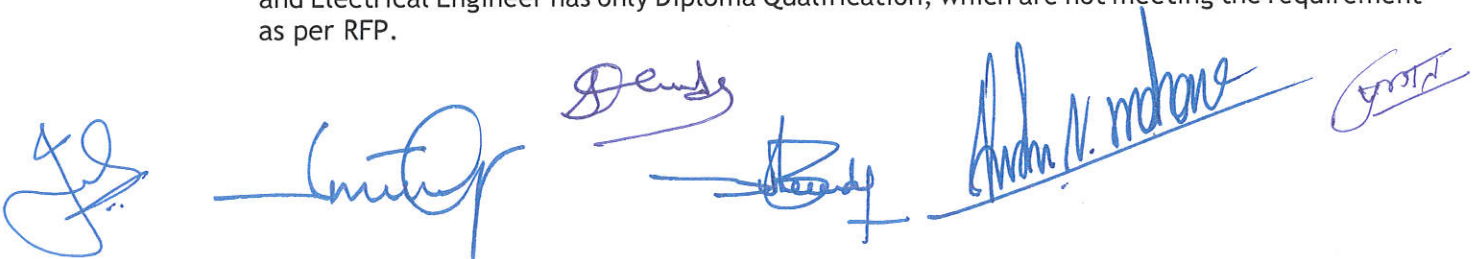
- The bidder has *furnished* the details for Average Annual Turnover during Last 3 years *duly certified by Chartered accountant*. The average Turnover is Rs.113 Lakhs which more than the requirement of Rs.42.09 Lakhs as per RFP.
- The bid capacity worked out to Rs.167.66 lakhs which is more than bid value of Rs.140.29 Lakhs.
- The Value of work done for Two similar nature of work are Rs.75.26 Lakhs & Rs.85.82 Lakhs, which is more than the requirement of Rs.70.15 Lakhs.
- The Bidder has not furnished the details of details of Power of Attorney as per Section-II, Clause 4.2 (a) & Section-III, Clause 1. Proprietorship Concern only furnished.
- The bidder has mentioned the details of vehicles as per Appendix to ITB Section-II, Clause 4.4. B (b)(i) and submitted the owned/leased invoice for Excavator cum Loader, Water Tanker (Tractor Trolley/truck mounted), Road Marking Machine, Self-Loading Concrete Mixer (SLCM) or Ready Mix Concrete , Crane 12 MT & Reflectometer, Vibratory Roller & Plate Compactor.
- With respect to staff qualification, the candidate proposed for Project Manager having 5 years of experience as a Project Manager and Site Engineer and Electrical Engineer are having only Diploma Qualification, which are not meeting the requirement as per RFP.
- As per Section-III, Clause 2(iii), the bidder has *furnished the undertaking for bid validity*. However, bidder has not mentioned the minimum days for bid validity of 120 days which is not meeting the requirement as per RFP.
- Hence, due to not meeting the above requirement as per RFP, the tender evaluation committee recommends to consider the bids as **"Non-responsive"**.

7.4 M/s. V Best Engineers:

- The bidder has *furnished* the details for Average Annual Turnover during Last 3 years *duly certified by Chartered accountant*. The average Turnover is Rs.1042 Lakhs, which is more than the requirement of Rs.42.09 Lakhs as per RFP.
- The bid capacity worked out to Rs.2281.28 lakhs which is more than bid value of Rs.140.29 Lakhs.
- The Value of work done for One similar nature of work is Rs.298.72 Lakhs which is more than the requirement of Rs.112.23 Lakhs.
- The Bidder has submitted the details of Power of Attorney as per Section-II, Clause 4.2 (a) & Section-III, Clause 1.
- The bidder has mentioned the details of vehicles as per Appendix to ITB Section-II, Clause 4.4. B (b)(i) and submitted the owned/leased invoice for Excavator cum Loader, Water Tanker (Tractor Trolley/truck mounted), Self-Loading Concrete Mixer (SLCM) or Ready Mix Concrete, Crane 12 MT, Reflectometer, Generator 250 KVA, Vibratory Roller & Plate compactor. But, the owned/rented invoice for one no. of Road Marking Machine is not furnished, which is not meeting the requirement as per RFP.
- With respect to staff qualification, Site engineer cum Material engineer has 11 yrs of experience, and Electrical engineers has 6 yrs of experience. Degree certificate for all the 3 candidates have been submitted by Bidder. As per bid submission, the candidate for *Project Manager having less than 10 years of experience as a Project Manager*, which is not meeting the requirement as per RFP.
- Hence, due to not meeting the above requirement as per RFP, the tender evaluation committee recommends to consider the bids as **"Non-responsive"**.

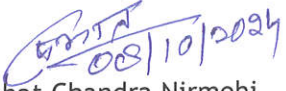
7.5 M/s. DHINGRA Brothers (India):

- The bidder has *furnished* the details Average Annual Turnover during Last 3 years *duly certified by Chartered accountant*. The average Turnover is Rs.7391 Lakhs, which more than the requirement of Rs.42.09 Lakhs as per RFP.
- The bid capacity worked out to Rs.4299 lakhs which is more than bid value of Rs.140.29 Lakhs.
- The Value of work done for the one similar nature of work is Rs.556 Lakhs which are more than the requirement of Rs.112.23 Lakhs.
- The Bidder has submitted the details of Power of Attorney as per Section-II, Clause 4.2 (a) & Section-III, Clause 1.
- The bidder has mentioned the details of vehicles as per Appendix to ITB Section-II, Clause 4.4. B (b)(i) and submitted the owned/leased invoice for Excavator cum Loader, Water Tanker (Tractor Trolley/truck mounted), Road Marking Machine Self-Loading Concrete Mixer (SLCM) or Ready Mix Concrete , Crane 12 MT (1 No), Reflectometer, Generator 250 KVA & Vibratory Roller & Plate compactor. However, the bidder has not submitted the owned/rented invoice for another 1 Number of Crane, which is not meeting the requirement as per RFP.
- With respect to staff qualification, as per bid submission, Site engineer cum Material engineer has 11 yrs of experience, and Electrical engineers has 6 yrs of experience. However, the candidate proposed for *Project Manager having 9 years of experience as a Project Manager* and Electrical Engineer has only Diploma Qualification, which are not meeting the requirement as per RFP.

- Hence, as the bidder has furnished the requirements as per RFP, the tender evaluation committee recommends to consider the bids as **"Non-responsive"**.

8. In view of the above and technical qualification of only one number of eligible bidders, Committee further recommended to terminate the tender process and invite for 2nd call by giving 7 days duration.

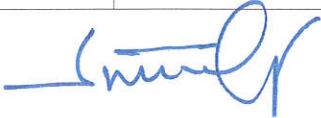

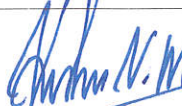
