Reasons for Technical Non-Responsiveness of the bidders:

1) M/s Ramesh Kumar Bansal

The Bidder has been considered as Technically non responsive as Bidder is not meeting the minimum required eligibility criteria of Bid capacity as per clause 2.2.2.1 of RFP. Further, the statement below the table of value of 'B' is not in line with the format provided at Annexure-VI of the RFP, thereby rendering the Bidder non responsive pursuant to clause 3.1.6.1 (a) of the RFP.
