Reasons for Technical Non-Responsiveness of the bidders:

1) M/s Ramesh Kumar Bansal

The Bidder has been considered as Technically non responsive as Bidder is not meeting the minimum required eligibility criteria of Bid capacity as per clause 2.2.2.1 of RFP. Further, the statement below the table of value of 'B' is not in line with the format provided at Annexure-VI of the RFP and value of B status shall be as on Bid Due Date as per RFP, thereby rendering the Bidder non responsive pursuant to clause 3.1.6.1 (a) of the RFP.

2) M/s R.G. Buildwell Engineers Ltd.

The Bidder has been considered as Technically non responsive as Bidder is not meeting the minimum required eligibility criteria of Technical capacity as per clause 2.2.2.2(iii) of RFP. Further, the statement below the table of value of 'B' is not in line with the format provided at Annexure-VI of the RFP and value of B status shall be as on Bid Due Date as per RFP, thereby rendering the Bidder non responsive pursuant to clause 3.1.6.1 (a) of the RFP.

3) M/s Shri Rajendra Kumar Kalal

The Bidder has been considered as Technically non responsive as Bidder is not meeting the minimum required eligibility criteria of Technical capacity as per clause 2.2.2.2(iii) of RFP. Further, as per Annexure-VI of RFP, the value of A (all five financial year) & value of B as on Bid Due date has not been certified by the Statutory Auditor. Therefore, the bidder has also been considered as Technically Non-responsive as per clause 2.2.2.1 of RFP.
