Reason of Non-Responsiveness:

Note-1 Shekhawati Enterprises- Shekhawati Entrepreneur Pvt. Ltd. (JV):

As per the client certificate provided the bridge work is not equal to or more than 36.76 Cr. so the said project is not considered for evaluation for single completed Major Bridge project. Hence, bidder is not meeting the criteria as per RFP 2.2.2.2 (iii) (a) One similar MajorBridge/ROB/Flyover project. Hence, the bidder may be considered as Technically Disqualified/ Non-Responsive.

The bidder is not meeting the minimum required Technical Threshold as per RFP clause 2.2.2.2 (i), further, the lead member of the bidder is also not meeting the 60% of Technical Threshold. Hence, the bidder may be considered as Technically Disqualified/ Non-Responsive.

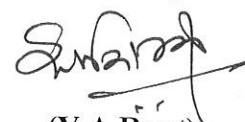
The bidder is considered Non responsive under clause 3.1.6.1 as the bidder is not submitted the Annex-V and Annexure-VIII and not provided the required undertaking for Local content as per clause 1.2.10.

Note-2 R.G. Buildwell Engineers Ltd.: the bidder has not submitted the reply to clarification asked. As per RFP clause 3.1.5 "If a Bidder does not provide clarifications sought under Clause 3.1.4 above within the prescribed time, its Bid may be liable to be rejected. In case the Bid is not rejected, the Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority". As per available data bidder is not meeting the criteria as per RFP 2.2.2.2 (iii) (a) One similar MajorBridge/ROB/Flyover project. Hence, the bidder may be considered as Technically Disqualified/ Non-Responsive.

Note-3 Tomar Construction Company - N.G. Constructions (JV): The provided client certificate has not mentioned the span length of Bridge. The client certificate mentioned as the agency has executed 2 minor bridges of 21.5 meter each in claimed project. Hence, the said project is not meeting the requirement as mentioned in clause 2.2.2.2 (iii) (a) of the RFP. Hence, the bidder may be considered as Technically Disqualified/ Non-Responsive.
