4. As per RFP Clause 5.4 (vii), the Expert Committee to take interview through VC of the key personnel of H1 consultant before issue of LOA of consultancy assignment under their jurisdiction. However, the interview of 5 key personnel shall be conducted after issuance of this LOA as per NHAI Policy Circular No. 10.1.36/2023 dated 26.09.2023 before expert committee in accordance with RFP clause 5.4 (vii). The reduction in remuneration after interviews, if any, shall be applicable as per RFP on the amount of **Rs. 5,57,61,149.95/-**.

6. You are also requested to furnish within 15 days of issue of this LOA, an unconditional Bank Guarantee as per details mentioned in Clause 11 of Section-2 of RFP, for an amount equivalent to 3% of the Contract Value, i.e. **Rs.16,72,835/- (Rupees Sixteen Lakh Seventy Two Thousand Eight Hundred Thirty Five Only)** towards Performance Security. This Bank Guarantee shall be as per relevant format given in the RFP. This Performance Security shall be valid for a period of 38 months i.e. up to 2 months beyond the expiry of the Contract of 36 months or you can submit Omnibus Bank Guarantee as per the provision of RFP.

7. Upon submission of required Performance Security, you are required to sign the Contract Agreement.

8. You are required to comply with the above and all the terms and conditions set forth in the bid documents. In case of any default on your part, you shall be liable for action as stated in the Bid documents.
