5. The above contract price is inclusive of all taxes, (other than Goods & Service Tax), duties, fees, levies and other imposition as may be levied under the applicable law and NHAI shall deduct

taxes as applicable, out of the eligible payments to be made to the Consultant. The amount towards Goods & Service Tax shall be paid by NHAI separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities by the consultant.

6. It is requested to furnish within 15 days of issue of this Letter of Acceptance (LOA), an unconditional Bank Guarantee from Nationalized Bank as per details mentioned in Clause 10 of Section 2 of RFP (LOI) for an amount equivalent to 3% of the total contract value **(3,50,01,000/)** i.e. **Rs. 10,50,030/- (Rupees Ten Lakh Fifty Thousand and Thirty only)** towards Performance Security. This Bank Guarantee shall be as per the relevant format given in the RFP. Copy of format of BG is enclosed for ready reference. Performance Security shall be valid for a period of 38 months i.e. upto 2 months beyond the expiry of the contract period.

7. Upon submission of the required Performance Security, you are required to sign the Contract Agreement with NHAI. Thereafter, the services shall commence immediately as per the Contract Provisions.

8. As per Clause 3.4 vii) (b) of Section 2 of RFP, "In case, the information contained in the CV for the duration in which the key personnel was employed by the firm, proposing his candidature is found incorrect / fake / inflated at any stage, action including termination of the consultancy agreement and debarment of the firm upto 2 years from future MoRTH or its executing agencies (e.g. NHAI) projects shall be taken by MoRTH or its executing agencies (e.g. NHAI)."

9. It is also requested to submit an undertaking as per Clause 3.4 (vii) (c) of RFP document which states that "*CVs of Key Personnel having intermittent inputs will be considered only if the assignments on hand, including those for which LOA has been received from the Client or for which Consultant has been declared as H1, do not exceed 3(three) for team Engineer In charge,, 2 (two) for Road Safety Expert and 3(three) for bridge/structural engineer as on 7 days before due date of proposal*".

10. The mobilization/deployment of all the of all the items/ resources as per provisions RFP will be mandatory without any exemption and no additional costs will be claimed for any of the items wherein considerably low rates are quoted.

11. You are requested to submit acceptance of the LOA within 07 (Seven) days from date of issue of this LOA.
