(excl. GST) is for a 5.5m wide intermediate lane road which does not fall under the category of similar work (2/4/6 lane highway/roadwork) and hence not considered by committee.
2	Vmaks Constructions Private Limited	Non-Responsive	The claimed certificate for works O&M works done as sub-contractor on Zirakpur-Patiala project highway at a cost of Rs.12.506 Cr. upto FY 2021-22 (16.63 Cr. after applying linking factor of 1.33) is inclusive of GST and as per Clause 4.4A(b)(i), the experience of 80% of the estimated project cost should be excluding GST, accordingly the claimed experience is found in-sufficient by committee.

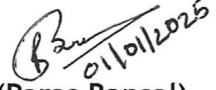
