In reference to subject cited above, bids were invited online for above work for which Notice Inviting Tender (NIT) was hosted at E-tender (www.etenders.gov.in) on 23.11.2024 vide tender ID 2024_NHAI_216011_1 as per RFP approved by Competent Authority vide E-office Computer no. 263791 wherein the last date for submission of bids was till 15:00 Hrs on 14.12.2024 and scheduled dated of bid opening was at 11:00 Hrs. on 16.12.2024. Two agencies have purchased tender documents along with term & conditions and paid cost of document amounting to Rs 1,000/- (inclusive tax) online in Authority's designated bank account, details of bidders are as under:

3. As mentioned above the Technical Bids were opened on 16.12.2024 at 11:00 Hrs. Based on technical evaluation, bids of both bidders i.e. **M/s Speed Travels** and **M/s Dhiraj Rai** are found technically responsive. The committee members have recommended that technical evaluation result may be uploaded on e-tender portal for inviting comments/queries, within 03 days. Financial bids of technical responsive bidders shall be opened thereafter.

4. Accordingly, the Technical Evaluation result has uploaded on e-tender portal for inviting comments. As there are no adverse comment received by any bidder, the date of opening of financial bids of technically qualified bidders has fixed on 11.01.2025. After opening of financial bids, the rates quoted by the bidders have been tabulated as under:

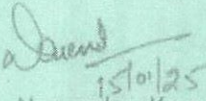
5. On the basis of above table, it has been found that M/s Dhiraj Rai, Village- Bihrojpur, PO- Shahgarh, Sadan, Azamgarh emerge out as L-1 bidder.

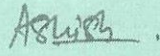
6. It is pertinent to mention that, one Innova (Crysta) for Project Director and One Scorpio for Dy. Manager(T) of PIU-Azamgarh is being provided by Contractor as per EPC Contract Agreement of the under construction projects of NH-31 (Greenfield Alignment). Hence, the tendered vehicle for the same category has only be kept in advance for any unusual situation emerges out by the Contractor's Vehicle.

7. Further, the rate quoted by the L-1 bidder has been compared by the nearby PIU i.e. PIU-Gorakhpur and it is found that the rate for Innova (Crysta) is 85,000/-, for Scorpio or equivalent is 82,000/- and for Indigo or equivalent is 60,000/- (each) has been approved by the committee under PIU-Gorakhpur. Hence, in light of approved rates in nearby PIU, only one vehicle i.e. Innova(Crysta) rate is slightly higher quoted by the L-1 bidder (M/s Dhiraj Rai).

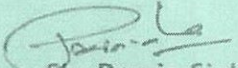
In view of above, the Committee hereby recommends to approve the hiring of vehicle from L-1 bidder i.e. M/s Dhiraj Rai, at Rs 90,000/- (Rupees Ninety Thousand only) for One Vehicle (Innova Cysta) per month, Rs 75,000/- (Rupees Seventy Five Thousand only) for One Vehicle (Scorpio) per month and Rs 1,10,000/- (One Lac Ten Thousand Only) for Two Vehicle (Bolero or equivalent) total amounting to Rs.2,75,000/- exclusive of GST for running within stipulated km for one year.
