This is in reference previous notes vide which NHAI HQ vide E-File no. 265879 has nominated Sh. Praveen Tyagi, DGM (MR) nominated as member of the committee regarding subject matter and has directed RO for further necessary action as per model RFP document for empanelment of advertising agencies at Regional Office issued vide Policy Circular No.4.33/2024 dated 10.06.2024.
