With reference to the subject tender, it is to inform that, the bid submitted by the firm, M/s K & J Projects Pvt. Ltd. in association with SEG Engineering Services Pvt. Ltd., Nagpur (Bid ID: 812257) was considered as "Non-responsive" in Technical Evaluation due to the debarment order issued by NHAI, HQ vide Lr. No. PROJ-28018(32)/1/2024-PIU Nagpur 1/E-249057 dated 08.04.2025.

2) However, based on the request received from the said bidder vide letter no. PROJ-28018(32)/1/2024-PIU Nagpur 1/E-249057 dated 08.04.2025, the tender committee has been learned that, the said debarment order is stayed upto 09.06.2025 (upto Next Hearing) by the order of Bombay High Court - Nagpur Branch dated 24.04.2025 & 06.05.2025 against the Writ Petition No.2233 of 2025 filed by the bidder, M/s K & J Projects Pvt. Ltd., Nagpur.

3) In this connection, based on the directions of Legal Advisor & Technical Division, NHAI, HQ, the Initial Technical Evaluation Results uploaded vide Minutes of Meeting dated 21.04.2025 in the CPP Portal for the subject SC Services tender (Tender ID: 2024_NHAI_220345_1) is hereby revoked.

4) Accordingly, the technical bid submitted by M/s K & J Projects Pvt. Ltd. in association with SEG Engineering Services Pvt. Ltd., Nagpur (Bid ID: 812257) is considered as "Responsive" in Technical Evaluation of the subject Consultancy Services tender subject to the outcome of Final Court Order of Bombay High Court - Nagpur Branch against the aforesaid Writ Petition.
