## Minutes of Meeting for opening & evaluation of the Financial e-Bids

**Sub.: Operation and Maintenance of facilities / amenities at Shirpur Toll Plaza** (km 205.000) on both sides (LHS & RHS) under Highway Nest (Mini) including tolls on MP/MH Border-Dhule Section of NH-52 (old NH-3) in the State of Maharashtra under the jurisdiction of Regional Office-Nagpur - Reg. \*\*\*

**This is in continuation of pre-page N/s 7:**

1. In continuation to the opening & evaluation of 'Technical e-Bids and with the approval of the Regional Officer, Nagpur at N/S-7, the Committee opened the 'financial e-Bids' of the SINGLE 'technically responsive Bidder' on 22.01.2025 at the scheduled time.

4. 'M/s. Akuti Amul & Food Parlour' is the SINGLE BIDDER who has quoted an Offer of **Rs. 30,555/-** (Rupees Thirty Thousand and Fifty-five only) per month for the subjected work as detailed at Annexure-IV.

5. As per NHAI Policy Circular No. 18.78/2022 dated 18.02.2022 (F/A) and MoRT&H Circular No. RW/NH-33044/25/2024-S&R (P&B) (Computer No. 240989) dated 28.08.2024 (F/B). The committee has carried out the "financial evaluation" of the received SINGLE BID keeping in view of the following conditions:

- a) The procurement was satisfactorily advertised, and sufficient time was given for submission of bids.
- b) The qualification criteria were not unduly restrictive; &
- c) The Price/s are reasonable in comparison to market values.
