Public Tender invited through e-tendering mode by Centralized Tendering Cell (CTC) on Government eProcurement System for above mentioned work for a value of Rs. 1,30,35,479/- (including GST). Technical bids for the above cited tender have been opened and in response **04 (Four)** bidders have submitted their bids as mentioned below.

1. M/s SAI CHAITRALI CONSTRUCTION AND SERVICES
2. M/s CIS GLOBAL INFRATECH PRIVATE LIMITED
3. M/s. RAMASHANKAR SINGH
4. M/s GOSWAMI FURNITURE HOUSE

Minimum criteria stipulated in NIT (Part -1 or Operating Part) of tender document for Pre-qualification of bidder are as under:

Clause 1.0 Work experience

Clause 1.1 Similar works:

The bidder shall have the experience of similar works satisfying the following eligibility criteria during last 07 (seven) years ending last day of month, previous to the commencement date of sale of tender. i.e. period is from **01-08-2017 to 31-07-2024**

- a) **03 (Three)** similar works completed each costing not less than **40%** of estimated cost i.e. Rs. **52.14 Lakhs**
OR
- b) **02 (Two)** similar works completed each costing not less than **50%** of Estimated cost i.e. Rs. **65.18 Lakhs**
OR
- c) **01 (One)** similar work completed costing not less than **80%** of Estimated cost i.e. Rs. **104.28 Lakhs**

1.2 Definition of similar work:

"Construction of Building or Civil structures (with or without supply of material)"

Clause 2.0 Financial criteria

Clause 2.1 Average annual financial turnover

Average annual financial turnover of bidder should be at least **30%** of estimated cost i.e. **39.11 lakhs** during the immediate last three consecutive financial years previous to the one in which tender sale has been commenced.

Clause 2.3 Solvency Certificate or Net worth Certificate

Solvency Certificate

Solvency certificate in the format as per **Appendix-5** issued by a Nationalized or any Scheduled bank in favour of the bidder should be for a value not less than at least **40%** of estimated cost put to tender **Rs. 52.14 lakhs**

OR

Net worth Certificate

Net Worth of the Bidder as per the latest audited financial year previous to the one in which tender sale has been commenced shall be at least **10%** of estimated cost put to tender **13.03 lakhs**. Also, Net Worth of the company has not been eroded by more than 30% in the last 03 (three) audited financial years previous to the last day of month previous to the commencement date of sale of tender.

OR

Credit Rating

Evidence of the credit rating of the bidder for long term debts (valid as on commencement date of sale / download of the tender, if rated) by any of the RBI approved rating agency shall be at least "Investment Grade" (as per RBI Guideline).

OR

Line of Credit

Bidder shall submit documentary evidence from a Nationalized or any Scheduled Bank (other than co-operative bank), stating that in the event of contract being awarded to the bidder, they will provide, if need arises, line of credit to the bidder for an amount of not less than 40% of estimated cost put to tender. *i.e. 52.14 lakhs*

Clause 3.0 Registration with EPF**Clause 4.0 PAN Registration****Clause 9.0 Make in India**

Evaluation of bidders is as under.

Bidder No. 1/4 M/s SAI CHAITRALI CONSTRUCTION AND SERVICES**Evaluated as per clause 1.0 Work Experience**

Bidder has submitted the work "Construction of Sub-station building and miscellaneous civil works at KAPP-3&4 site" vide Work Order No. KAPS/CTC/3-4/CIVIL/CAP/2020/WO-80466 Dtd. 03/10/2020 executed for M/s. NPCIL, KAPP-3&4 with an executed value of work Rs. 1,82,14,706/- completed on 31/08/2022. The value of work is more than required 80% of estimated cost i.e. Rs. 104.28 lakhs and falls in line with similar definition of work.

Hence, the bidder is qualified under PQ Clause No. 1(c).

Evaluated as per clause 2.0 Financial criteria**Clause 2.1 Average annual financial turnover**

Bidder's annual turnover of last three years based on submitted documents is Rs 129.83 lakhs which is more than the required value of Rs. 39.11 lakhs. Hence, Bidder is qualified under PQ clause No. 2.1.

Clause 2.3 Solvency Certificate or Net worth Certificate or Credit Rating or Line of Credit

Bidder has submitted net worth certificate of net worth value (submitted FY-2022-23) of Rs. 109.18 lakhs which is more than required value of Rs. 13.03 lakhs.

Bidder has submitted CA certificate that "the audit process for FY 2023-24 is under process and is therefore qualified under Clause 2.3.

Evaluated as per Clause 3.0 Registration with EPF

Bidder has submitted copy of EPF registration bearing EPF No. GJ/SRT/32945/E-I/3979. Hence, Bidder is qualified under PQ clause No. 3

Evaluated as per Clause 4.0 PAN Registration

Bidder has submitted copy of PAN registration bearing PAN No. AADPE3203A. Hence, Bidder is qualified under PQ clause No. 4

Evaluated as per Clause 9.0 Make in India

Bidder has submitted Annexure-9 (Certification under preference to Make in India Order) with 95% local content. Hence, Bidder is qualified under PQ Criteria Clause 9.0.

Overall, Bidder is qualified under all PQ Clauses 1.1(c),2,3,4 and 9.

Bidder No. 2/4 M/s CIS GLOBAL INFRATECH PRIVATE LIMITED

Bidder has not deposited EMD and has submitted MSME certificate. As per Schedule A (Clause No. 7 of STC), Purchase Preference and waiver of Bid security to MSMEs is not applicable for this bid. Therefore, Bid is rejected due to non-submission of EMD.

Bidder No. 3/4 M/s. RAMASHANKAR SINGH**Evaluated as per clause 1.0 Work Experience**

Bidder has submitted the work "Construction of Documentation Centre and other miscellaneous works at KAPP-3 and 4 Plant site" vide Work Order No. KAPS/CTC/3-4/CIVIL/CPP/2022 Dtd. 13/09/2022 executed for M/s. NPCIL, KAPP-3&4 with an executed value of work Rs. 1,09,02,836/- completed on 14/12/2023. The value of work is more than required 80% of estimated cost i.e. Rs. 104.28 lakhs and falls in line with similar definition of work.

Hence, the bidder is qualified under PQ Clause No. 1(c).

Evaluated as per clause 2.0 Financial criteria**Clause 2.1 Average annual financial turnover**

Bidder's annual turnover of last three years based on submitted documents is Rs 439.36 lakhs which is more than the required value of Rs. 39.11 lakhs. Hence, Bidder is qualified under PQ clause No. 2.1

Clause 2.3 Solvency Certificate or Net worth Certificate or Credit Rating or Line of Credit

Bidder has submitted net worth certificate of net worth value (submitted FY-2023-23) of Rs. 247.37 lakhs which is more than required value of Rs. 13.03 lakhs.

Evaluated as per Clause 3.0 Registration with EPF

Bidder has submitted copy of EPF registration bearing EPF No. GJ/SRT/31688/E-I/APP/1425. Hence, Bidder is qualified under PQ clause No. 3

Evaluated as per Clause 4.0 PAN Registration

Bidder has submitted copy of PAN registration bearing PAN No. ABDFR0734J. Hence, Bidder is qualified under PQ clause No. 4

Evaluated as per Clause 9.0 Make in India

Bidder has submitted Annexure-9 (Certification under preference to Make in India Order) with 95% local content. Hence, Bidder is qualified under PQ Criteria Clause 9.

Overall, Bidder is qualified under PQ Clause 1.1(c) ,2,3,4 and 9.

Bidder No. 4/4 M/s GOSWAMI FURNITURE HOUSE

Bidder has not deposited EMD and has submitted MSME certificate. As per Schedule A (Clause No. 7 of STC), Purchase Preference and waiver of Bid security to MSMEs is not applicable for this bid. Therefore, Bid is rejected due to non-submission of EMD.

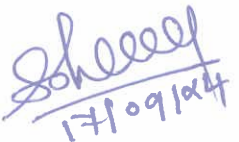

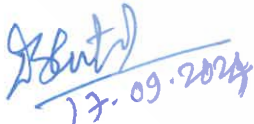

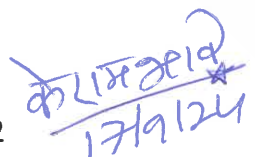
