Section-2 Memorandum of agreement is not submitted. If bidder become L-1, Section-2 to be obtained from bidder.
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.
- 4) 4/12 M/s Raghav Construction
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.
- 5) 5/12 M/S NAMBAHDUR
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.
- 6) 6/12 M/S Technical Construction Co.
Data given in excel sheet (format-3) & format-3 submitted on C.A. letter head signed by C.A is mismatch, Hence disqualified under 2.3 P.Q. Criteria.
- 7) 7/12 M/S WIN-TECH ENGINEERS & CONTRACTORS
Now Submitted Appendix-12 & Section-II.
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.
- 8) 8/12 M/s Goswami Furniture House
Appendix-12 not submitted. Hence Disqualified
- 9) 9/12 M/s ADVANCE SURFACE TECHNOLOGY
Appendix-12 not submitted. Hence Disqualified.
- 10) 10/12 M/s UNITED ENGINEERS
Appendix-12 not submitted. Hence Disqualified.

11) 11/12 M/s BISHAN CHAND AND CO.
Disqualified under 2.3 of P.Q. Criteria.

12) 12/12 M/s SANDIPKUMAR RAJESHWARPRASAD MISHRA.

1. Work submitted as proof for work experience was NDCT KAPP-3&4 Work which was originally issued to M/s. LARSEN & TOUBRO by NPCIL.
2. M/s. LARSEN & TOUBRO have given some part of that work as sub contract to M/s SANDIPKUMAR RAJESHWARPRASAD MISHRA.
3. Bidder was asked to submit approval obtained by Larsen & Toubro Limited from NPCIL regarding sub contracting to M/s SANDIPKUMAR RAJESHWARPRASAD MISHRA.
4. Bidder has not submitted above referred approval papers. It is clear that NPCIL GCC is applicable to NDCT KAPP-3&4 Work and as per GCC prior approval is required for sub contracting / sub letting.

Hence, work submitted as proof of work experience cannot be considered. Bidder is disqualified under work experience criteria.
