1. आपको यह सूचित करना है कि निविदा द्वारा दिए गए दरों और मात्राओं की अनुसूची में दिखाए गए कार्य मर्दों के लिए आपके द्वारा प्रस्तुत निविदा और उपरोक्त संदर्भित अनुवर्ती पत्रों में संशोधित के अनुसार वस्तु

एवं सेवा कर @ 18% सहित कुल मूल्य (₹. 43, 17,112/- + वस्तु एवं सेवा कर ₹. 7, 77,080/-) ₹. 50,94,192/- (पचास लाख चौरानबे हजार एक सौ बानबे) के लिए कृते न्यूपाकाइलि और की ओर से स्वीकार किया गया है।

This is to inform you that the tender submitted by you and modified in subsequent letters referred above has been accepted for and on behalf of NPCIL, for the items of work shown in the schedule of quantities and rates covered by the tender for a total value of (₹.43,17,112/- + Goods & Service Tax ₹. 7,77,080/-) ₹. 50, 94,192/- (Rupees Fifty Lakh Ninety Four Thousand One Hundred and Ninety Two only) including Goods & Service Tax @ 18%

2. कार्य का निष्पादन निविदा दस्तावेज़ में उल्लिखित निबंधनों, शर्तों, विशिष्टताओं और आरेखण के अनुसार सख्ती से और साथ ही साथ सर्वश्रेष्ठ कामगार द्वारा किया जाएगा। आपको कार्य पर हमेशा अर्हतापूर्ण अभियंताओं/पर्यवेक्षकों को नियोजित करना होगा तथा पर्यवेक्षण करना होगा। इस कार्य की संतोषजनक पूर्ति हेतु आवश्यक ऐसी मशीनरी तथा उपस्करों और अन्य सामग्रियों को लगाना होगा और जरूरत होने पर स्थल को भी लाना होगा।
