Minutes of Meeting of SSLV - "Contract Finalization Committee" (CFC) – Reg

1. Introduction:

NSIL has floated tenders to ISRO qualified supply chain vendors of SSLV and the vendors were asked to respond to these tenders in two parts viz., Technical and Financial bid. Responses are received for **Indent 6-2**.

CMD NSIL vide Ref No: NSIL/SSLV/CFC-S/2023 has constituted a SSLV "Contract Finalization Committee" to evaluate the responses received for the procurement of the items.

As part of this, **Annexure 1** lists the indent number and indent items for tender.

2. Evaluation Process:

In order to evaluate the bid responses, NSIL has consolidated & forwarded the technical bids to VSSC for review and assessment. After the detailed evaluation of technical proposals submitted by the vendors, VSSC has given recommendations/comments based on the information given by vendors.

The recommendations/comments by VSSC are attached as **Annexure 2**.

3. Summary of discussion:

Based on the documents/ certificates/ clarifications/ input provided by the vendors on their bid proposal, the SSLV "Contract Finalization Committee" carried out the bid evaluation.

Committee has noted the technical evaluation carried by SSLV Project of VSSC. Further to the technical evaluation, the committee evaluated the delivery schedule and other commercial terms and conditions.

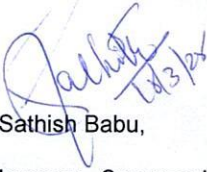
4. Recommendation:

During the review of the technical bid, it has been observed that party has indicated thickness tolerance of $6^{(+0.5-0)}$ mm (as per the tender terms it should be $6^{(+0.4-0)}$ mm). Following which, clarifications was sent to Jindal to accept as per the tender terms vide mail dt March 12, 2025.

Jindal vide email dt March 12, 2025 accepted the thickness tolerance $6^{(+0.4-0)}$ mm. (Annexure 3)

The SSLV "Contract Finalization Committee" has recommended the following bidder, as listed in the table, as technically qualified bidder so that their financial bid may be opened, based on the thorough technical review of the following proposal.

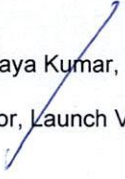
