1. Introduction:

CMD NSIL vide Ref No: NSIL/SSLV/CFC-S/2023 has constituted a SSLV "Contract Finalization Committee" to evaluate the responses received for the procurement of the items.

2. Evaluation Process:

In order to evaluate the bid responses, NSIL has consolidated & forwarded the technical bids to VSSC for review and assessment. After the detailed evaluation of technical proposals submitted by the vendors, VSSC has given recommendations/comments based on the information given by vendors.

3. Summary of discussion:

Based on the documents/ certificates/ clarifications/ input provided by the vendors on their bid proposal, the SSLV "Contract Finalization Committee" carried out the bid evaluation.

Committee has noted the technical evaluation carried by SSLV Project of VSSC. Further to the technical evaluation, the committee evaluated the delivery schedule and other commercial terms and conditions.

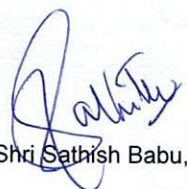
