Non-submission of PBG/SD within stipulated period may lead to annulment of the contract, forfeiture of the bid security and action against you as per tender terms & conditions.

On submission and acceptance of Performance Security, within 15 days you are also required to execute an agreement on a Non-Judicial stamp paper worth ₹ 100/- as per the prescribed pro-forma vide Annexure-II of GCC.

Till the formal agreement is signed, this NOA along with bid and all correspondences shall constitute a binding on this contract between ONGC Ltd. and M/s Vijay Kumar Rastogi.

Please note that the time allowed for carrying out the work as mentioned in the bid document is **four months**, which shall be reckoned from the 15th day of issuance of NOA or date of actual handing over of the site, whichever is later.

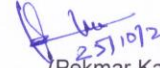
