Sir,

- 1.0 Oil and Natural Gas Corporation Limited (ONGC) is pleased to award a firm Contract through this Notification of Award (NOA) to "**M/s AMROCK, Ahmedabad**", located at B-1101, 11th Floor, West Gate, Nr. YMCA Club, SG Highway, Ahmedabad – 380015, for execution of the entire scope of works for "**Fabrication, Digital Printing, Supply & Installation of Signboards at ONGC Hazira Plant**" against ONGC's Tender No. **ZV8AC24002**, on a lumpsum turnkey (LSTK) basis, with the scope of work and on the terms and conditions as detailed in ONGC's tender / bidding documents, addenda (technical & commercial), and all subsequent communications (letters, notifications, e-mails, faxes) issued by ONGC. The contract is awarded at a total lumpsum price of ₹ **2,68,96,247.40/- (INR Two Crore Sixty Eight Lakh Ninety Six Thousand Two Hundred & Forty Seven and Paise Forty Only)** inclusive of GST, taxes, duties and levies as applicable
- 2.0 The lump sum contract price is based on the scope of work (Complete TBP) and the price bid submitted in the bidding documents.
- 3.0 All terms and conditions including payments, shall be governed in accordance with ONGC's bidding documents and subsequent correspondences, documents, and addenda referenced above, read together with this NOA.
- 4.0 The lump sum contract price, as stated in Para 1.0, shall remain firm and valid until the entire scope of works is satisfactorily completed, and shall not be subject to escalation on any grounds whatsoever. ONGC will make necessary deductions for taxes from the invoices and payments to be made or adjusted, as per the applicable legal provisions.

Necessary deductions on account of taxes etc. shall be made by ONGC from the invoices or payments to be made/adjusted as per applicable provisions of Law.
- 5.0 The scheduled period for completion of the LSTK works, as described in the bidding documents, is **12 months** from the date of the NOA i.e., by **06.10.2025**.

6.0 M/s AMROCK (the Contractor) is required to furnish **Performance Bank Guarantee (PBG)** in the form of NEFT/RTGS/Electronic Fund Transfer or an unconditional and irrevocable Electronic Bank Guarantee (e-BG)/SFMS Bank Guarantee (SFMS BG) as per the proforma mentioned in the General Conditions of Contract (GCC) in the bidding documents, for due performance of the contract. The PBG must be for a sum of ₹ **26,89,624.74/- (INR Twenty Six Lakh Eighty Nine Thousand Six Hundred & Twenty Four and Paise Seventy Four Only)**, which is equivalent to **10% of the total contract price**, and must be submitted within 15 days from the date of this Notification of Award (NOA), i.e., by **22.10.2024**, and shall remain valid up to the scheduled completion date of the work, plus the warranty period of **12 months**, plus **60 days**, i.e., until **05.12.2026**.

The default/Preferable mode of submission of Bid Security will be NEFT/RTGS/Electronic fund transfer or e-BG, however, whenever a contractor submits an SFMS BG, **they will mandatorily be required to submit a letter from the issuing bank that it is unable to issue a NeSL based e-BG as on date**. Such letter should accompany the SFMS Bank Guarantee (SFMS-BG).

The Contractor is requested to confirm within **03 days** of issuance of this NOA that PBG shall be submitted within 15 days from date of NOA and non-submission of PBG within stipulated period may lead to annulment of the contract and actions as per tender/NOA conditions.

- 7.0 The Contractor is also requested to visit this office in person on any working day to sign a formal contract agreement with ONGC within **30 days** from the date of this NOA. The contract shall be signed after submission of the PBG. Non-compliance of above, will lead to forfeiture of EMD and cancellation/ termination of award of work beside other actions as per tender/ NOA conditions.
- 8.0 This Notification of Award constitutes a binding contract between ONGC and M/s AMROCK, subject to all terms and conditions of the bidding documents and other referenced communications until the formal agreement is executed. No payment will be made for work performed until the PBG is submitted and the formal contract agreement is signed.
- 9.0 All other terms and conditions shall be as per the tender/bidding documents and any subsequent amendments for this tender.
- 10.0 Intimation regarding the kick-off meeting for this project will be communicated shortly.
- 11.0 M/s AMROCK shall provide all necessary compliance documentation and Invoices required under GST legislation to enable ONGC to avail of Input tax (GST) credit.
- 12.0 The effective date of the commencement of the contract is the date of this NOA, i.e., **07.10.2024**. The contractor is requested to contact **Engineer-in-Charge** for site handover and further instructions for the execution of the work.
