3.2 As per approval of CPA vide noting dated 13.09.2024, the clarifications were sought from the following 02 bidders on 17.09.2024 through <https://etender.gov.in> website, and requested to submit the replies latest by 23.09.2024:

3.2 The Post Bid Conference (PBC) was kept on 20.09.2024 in order to clear the Bidders' doubts, if any, regarding the Clarifications sought. But, No bidder attended the PBC.

3.3 Out of 2 bidders from whom clarifications were sought, only One Bidder i.e. **(1/5) M/s S. P. Chaudhari** has not submitted the reply, 1 bidders have not submitted the documents as per requirement. Thus it appears that they don't have the requisite documents to qualify in the bid, thus it is not prudent to enter second round of clarification declaring present situation as exceptional circumstance. As per **IMMM para 13.4.4** cases where post bid conference is held, normally second round of clarification shall not be required.

3.4 Further, based on deliberations hereunder, 4 Bidders out of 5 bidders are getting techno-commercially qualified, resulting into aggregate TA-CA bidders, thus it is not prudent to enter to second round of clarifications.

3.5 The Comparative statement based on the deficient documents received from the Bidders during Clarification is prepared and duly vetted by finance officer on 17.09.2024.
