

F. PEC Recommendations:

In view of above deliberations, PEC recommends:

F.1 To award the **43.30% of total work i.e. Rs. 1,57,76,159.30/-** (inclusive of 18% GST), to B-2 (M/s LOHIT CHANDRA GOGOI, V.C- 932764) for “Repair/Renovation of vacant flats at Nazira & Sivasagar colonies” for an amount of **Rs. 1,57,76,159.30/-**(inclusive of 18% GST), which is at PAR with estimated cost put to tender (inclusive of 18% GST).

F.2 To award the **39.89 % of total work i.e. Rs.1,45,36,259.85/-** (inclusive of 18% GST) to B-6 (M/s B K GOGOI, V.C.- 819611) for “Repair/Renovation of vacant flats at Nazira & Sivasagar colonies” for an amount of **Rs.1,45,36,259.85/-**(inclusive of 18% GST), which is at PAR with estimated cost put to tender (inclusive of 18% GST).

F.3 To award the **16.81% of total work Rs.61,26,153.89** inclusive of 18% GST), to B-7 (M/s Brahmaputra Commerce & Trade, V.C-819660) for “Repair/Renovation of vacant flats at Nazira & Sivasagar colonies” for an amount of **Rs.61,26,153.89/-**(inclusive of 18% GST), which is at PAR with estimated cost put to tender (inclusive of 18% GST).
