1. Your tender for the work mentioned above has been accepted on behalf of Oil & Natural Gas Corporation Ltd. at your quoted price of ₹ 23, 00,233.00 (Rupees Twenty Three Lakh Two Hundred Thirty Three Only with TPI services per man-day rate @ Rs. 3,432.62 for Civil, Rs. 3,432.62 for Electrical and Rs. 3963.62 for IT/Info-com), which is 6.57 % above the estimated cost of ₹ 21, 58,338.00 put in the tender.
2. The above mentioned contract price or man day rate shall be inclusive of all taxes, duties, fees overheads etc. and other costs as detailed in the bidding document, but not limited to the following-
 - (i) All taxes duties, fees, overheads etc.
 - (ii) Computer time, Secretarial typing, clerical services, etc.
 - (iii) Administrative, Managerial, Legal, services etc.
 - (iv) Reprographic services, Materials, Photocopy, Stationery etc.
 - (v) All local traveling, lodging, boarding Communication charges including telephone, telefax, courier etc. ONGC shall not make any payment on account of intra/intercity air, train, vehicle, travel, conveyance charges boarding and lodging etc.
3. The payment shall be made for actual number of performed man-days. One man-day (Onshore India) shall be considered @ 8 hours per day. No overtime allowance shall be payable. The quoted rate per man day as above shall remain firm and valid till completion of TPI services and shall not be subject to escalation on any grounds whatsoever.

4. You are required to furnish submit the Security Deposit (SD) in the form of NEFT/RTGS/Electronic fund transfer to designated account of ONGC or in lieu thereof an irrevocable Electronic Bank Guarantee (e-BG)/SFMS Bank Guarantee (SFMS BG) (as per the proforma enclosed in annexure-1 amounting to Rs. 2, 30,023.00 (Rupees Two Lakh Thirty Thousand Twenty Three Only) within 15 days of issue of this NOA. If the Performance Security is submitted in the form of e-Bank Guarantee, the BG shall be valid initially up to scheduled completion date of the contract plus 60 days, and you shall be required to provide the details of e-BG such as Number, Date, Name of issuing bank and amount.
5. You are also requested to confirm within 03 days of issue of the NOA that Performance Security shall be submitted within 15 days from the date of NOA. Non-submission of Performance Security within stipulated period may lead to annulment of the contract and action shall be taken against you as per Tender terms & conditions.
6. You are required to furnish a non-judicial stamp paper worth Rs.100.00 purchase in your name for execution of detailed contract agreement within 30 days from date of issue of this letter. Till the formal agreement is signed, this NOA along with your offer and other correspondences will act as binding agreement between ONGC Ltd. and M/s International Certification Services Pvt. Ltd.
7. Please note that the time allowed for carrying out the work as mentioned in the bid document is 10 (Ten) months/260 days each for Civil & Electrical and 05 (Five) months/130 days for Info-com/IT works, which shall be reckoned from date of issue of work order or actual start date of deployment of TPI personnel, whichever is later.
8. You shall be required to mobilize your personnel for commencement of services at the specified site within a maximum of 7 days from the date of first intimation of mobilization from ONGC for inspection (site/vendor) any time after this notification.
9. For all further activities pertaining to submission of Performance Security, execution of Agreement, mobilization and execution of the work, please visit this office within the schedule as described earlier.
