- 1.0 Oil and Natural Gas Corporation Limited (ONGC) hereby places this Notification of Award (NOA) on M/s International Certification Services Pvt. Ltd., Mumbai, for execution of job "Inspection of project - Creation of C3 C4 recycling facility at ONGC, Dahej Plant" against GePNIC tender Id 2024_ONGC_204405_1 (ONGC e-tender no. BUCKL24011) as per scope of work, specifications and the terms and conditions as detailed in ONGC Bidding Documents, amendments and subsequent letters issued by ONGC, at the total quoted lump sum price **INR 15,53,405/- (Rupees Fifteen Lakhs Fifty Three Thousand Four Hundred Five only, inclusive of all taxes, duties, freight, insurance etc.)**.
- 2.0 The above mentioned lump sum Price shall be inclusive of cost of Services, Insurance, all Taxes and Duties, Transportation/Handling Cost & other costs as detailed in Bidding Documents and other documents / correspondences as mentioned reference above for the entire scope of work.
- 3.0 All the terms and conditions including the payment against the contract shall be regulated in accordance with ONGC's Bidding Documents, amendments and subsequent correspondences / documents as mentioned in reference above, read with this NOA.
- 4.0 The lump sum price as stated in Para 1.0 above shall remain firm and valid until the entire scope of work is completed satisfactorily and shall not be subject to any escalation on any ground whatsoever, except for provisions under change in law or any further amendments issued by ONGC.

Necessary deductions on account of Tariffs, taxes, duties, fees and levies as aforesaid shall be made by ONGC from the invoices or payment to be made / adjusted as per applicable provisions of Law.

5.0 The contract shall be valid for 500 days from the date of this NOA, i.e. up to 07.03.2026.

6.0 Mobilization

M/s International Certification Services Pvt. Ltd. shall be required to mobilise their personnel for commencement of services at the specified site(s) within a maximum of 7 days from the date of first intimation of mobilization from ONGC for inspection (site/ vendor) after placement of NOA.

7.0 Liquidated Damages

If M/s International Certification Services Pvt. Ltd. is unable to mobilize / deploy and commence the services within the period specified in sub clause (a) above, it may request ONGC for extension of time, unconditionally agreeing for levy and recovery of LD. Upon receipt of such a request, ONGC may at its discretion, extend the period of mobilization and shall recover from the contractor, as an ascertained and agreed Liquidated Damages, a sum equivalent to 1/2 % of contract value, for each week of delay or part thereof, subject to a maximum of 10% of the contract value.

8.0 SEZ Clause

Dahej plant being an SEZ Unit, GST is exempted based on submission of requisite documents to ONGC. Deductions as applicable will be made at source by ONGC towards Corporate Tax while making payments.

9.0 Performance Guarantee / Security Deposit:

The Contractor shall furnish to ONGC, the following performance guarantee in the form of NEFT/RTGS/Electronic fund transfer to designated account of ONGC or in lieu thereof an irrevocable Electronic Bank Guarantee or in lieu thereof submit irrevocable Unconditional Insurance Surety Bond for due performance of the Contract:

- a) **M/s International Certification Services Pvt. Ltd., Mumbai** shall furnish security deposit in the form of NEFT/RTGS/Electronic fund transfer to designated account of ONGC or in lieu thereof an irrevocable Electronic Bank Guarantee for due performance of the Contract as per the proforma attached herewith, from a nationalized / scheduled bank for **INR 77,670/- (Rupees Seventy Seven Thousand Six Hundred Seventy Only)** against the NOA to be submitted within 15 days of placement of NOA, and should be valid till the scheduled contract period plus claim period of 60 days or in lieu thereof submit irrevocable Unconditional Insurance Surety Bond from Insurance Company registered with Insurance Regulatory and Development Authority of India (IRDAI).



11.0 **M/s International Certification Services Pvt. Ltd., Mumbai** shall be required to sign a formal contract with ONGC within 30 (Thirty) days from the date of this Notification of Award. You are therefore requested to attend this office in person on any working day for executing the Agreement with ONGC. This Notification of Award shall constitute binding contract between **M/s International Certification Services Pvt. Ltd., Mumbai** and ONGC and shall be subject to all terms and conditions of the bidding documents and other documents mentioned in reference above.
