

Minutes of PEC for award of job against GePNIC tender Id 2024 ONGC 204405 1 (e-tender no. BUCKL24011) for job “Engagement of TPI agency for Inspection of project - Creation of C3 C4 recycling facility at ONGC, Dahej Plant”

CS has been vetted by Finance section on 06.09.2024.

It is observed that the price quoted by L-1 bidder, i.e. M/s International Certification Services Pvt Ltd, Mumbai is INR 15,53,405/- which is lower by INR 17,66,595/- (i.e. 53.21%) of the tendered value. Hence, PEC considers the rate quoted by L-1 bidder as reasonable.

3.0 RECOMMENDATIONS:

In view of deliberation as above, PEC recommends the following:

- a. Placing of work order on M/s International Certification Services Pvt Ltd, Mumbai (Vendor Code: 834517) for job “Engagement of TPI agency for Inspection of project - Creation of C3 C4 recycling facility at ONGC, Dahej Plant” for an amount of INR 15,53,405/-.

Sanctioned Amount: INR 33,20,000/-.

CPA: L-III level officer as per clause 24.1 of BDP.
