7.0 As per reply to the queries sought to M/s Certification Engineers International Limited and submitted documents , it is concluded that the offer of M/s Certification Engineers International Limited is technically acceptable based on documents submitted in gov etender portal and subsequent clarifications.

8.0 Procurement Evaluation Committee

The following Procurement Evaluation Committee members met on 13.09.2024 to deliberate the bids & clarifications that were received against the subject tender:

9.0 Observation & Deliberations:

- PEC observed that the instant case is of Limited Tender (single bid) invited from the empanelled agencies through GePNIC portal.
- PEC observed that out of eight Empanelled agencies, Five empanelled agencies have submitted the bid. All five agencies are registered with Ministry of MSE and have furnished Udyam Registration certificate for claiming Purchase Preference being MSE-bidder.
- PEC noted the status of the the L-1 bidder i.e. M/s.Certification Engineers International Limited, after post bid clarification as under:

(b) Commercial:

- (i) Bidder has quoted total price of ₹ 26,76,968/- (inclusive of 12% GST) and is L-1 bidder as mentioned at para no. 2.0 above. The quoted total price is 24.55% lower than estimated cost i.e. ₹35,47,992.

Conclusion: Bid is technically and commercially acceptable and bidder has emerged as L-1 bidder as per table at para 2.0 above.
