1. **Scope Of Work**: The scope of work shall be as per Annexure-III of subject tender.
2. **Conditions of Contract**: The Contract shall be governed by the Terms and Conditions & Scope of Work contained in the Tender No. – UP1AC24003
3. **Rates & Quantities**: Details of Scheduled items, Unit Rates & quantities to be executed are as per the above-mentioned Quotation.
4. **Terms of Payment**:
 - a. No advance payment shall be made by ONGC to the contractor.
 - b. It may be noted that payment will be made on actual Material and Service provided.
 - c. 100% payment shall be released after successful completion of the job in all respect and submission of Job Completion Certificate.
5. **Guarantee/warranty**: As per GUARANTEE/ WARRANTY clause at Annexure-II of the tender and Special Condition of Contract (Technical) as mentioned in the Tender Document.
6. **Inspection**: As per Clause No.-47.0 at Annexure-II of the tender and Special Condition of Contract (Technical) as mentioned in the Tender Document.
7. **Performance Security Deposit**: You are required to submit a Security Deposit within **15 days** of issue of this LOA for an amount equivalent to 10% of contract value i.e. ₹ 1, 98, 000 (Rupees One Lakh Ninety-Eight Thousand Only) valid for [Scheduled Completion Period + Guarantee/Warranty period as stipulated in the contract + 90 days] + 30 days (claim period). Please note that the validity of the BG/Security Deposit shall be up to 17.08.2026. Validity of BG/Security Deposit claim period shall be up to 17.09.2026. However, BG/Security Deposit shall be returned as per completion period if it is earlier.

- i. **Contract Period: 06 months** from the date of placement of LOA.

- iii. **Mobilisation Period:** There is no separate Mobilization Period. Mobilization period is inclusive of total contract period.

9. **Signing of Contract Agreement:** You are requested to depute your authorized signatory to the office of the undersigned along with Power of attorney, stamp paper etc. for signing of the Contract Agreement in the prescribed proforma on non-judicial stamp paper of Rs 100/- (bought in the name of ONGC, Uran) within **30 days** of issue of this LOA.
10. **Kick off Meeting:** You are requested to visit Uran plant within a week after receipt of LOI/LOA for kick off meeting with designated Engineer-in-Charge [Sh. Arun Rawat, Manager (Security), Mob-7042693841] pertaining to activity wise detailed execution period & plan.
11. Please note that if you intend to engage 20 (Twenty) **[OR]** more workmen during execution of the job, then as per labour law you need to obtain "Labour License" from the office of "Labour Commissioner, Govt. of India, Sion (E), Mumbai". Necessary "Form-III" from "Principal Employer-I/C Contract Cell" shall have to be obtained by you before applying for issue of "Labour License" from said statutory authority.
12. **Statutory Requirements:** You are required to comply, maintain & provide (on demand) the updated status record of statutory requirements/guidelines issued by statutory authorities pertaining to the engaged contractual labour/manpower for the timely execution of the said job.
