

F. PEC Recommendations:

In view of above deliberations, PEC recommends:

F.1 To award the work:

- F.1.1 For Subhead-1:** To M/s Keshab Gogoi, V.C-915107 (B-1) at his quoted amount of Rs.2,33,92,655.00/- (inclusive of 12% GST), which is "At PAR" on the estimated cost put to tender for subhead-2 inclusive of 12% GST.
- F.1.2 For Subhead-2:** To M/s Lechaman Borgohain, V.C-831707 (B-1) at his quoted amount of Rs.63,53,501.00/- (inclusive of 12% GST), which is "At PAR" on the estimated cost put to tender for subhead-2 inclusive of 12% GST.
