Even though four bidders have participated bidder 4/4 Sandeep builders was not evaluated due to non submission of EMD.

After first & second round of clarification from the three balance bidders viz., 1/4 N. Chinnathambi, 2/4 Sri Durga construction & 3/4 Nithya Sree it was evaluated to reject the bids of 1/4 N. Chinnathambi due to non extension of bid validity and non submission of deficient document and to qualify the bidder 2/4 Sri Durga Construction.

After third round of clarification bidder 3/4 Nithya Sree was proposed to be rejected due to non submission of required deficient document and open the price bid of the only qualified bidder 2/4 Sri Durga construction.

Vide Cl. 14.1.8 of IMM Manual , as and when a single offer situation gets triggered against a tender after opening of Price bid, the Procurement Evaluation Committee shall need to be re-constituted at appropriate level in relation to the level of revised CPA .
