

F. PEC Recommendations:

In view of above deliberations, PEC recommends:

F.1 To award the work:

F.1.1 For Subhead-1: To M/s CHANDAN GOGOI, V.C.- 893504 (B-1) at his quoted amount of Rs.2,17,59,226.00/- (inclusive of 12% GST), which is "At PAR" on the estimated cost put to tender for subhead-1 inclusive of 12% GST.

F.1.2 For Subhead-2: To M/s Ahad Ali, V.C.- 818785 (B-2) at his quoted amount of Rs.61,18,423.00/- (inclusive of 12% GST), which is "At PAR" on the estimated cost put to tender for subhead-2 inclusive of 12% GST.

F.2 To obtain performance security @10% of estimated value of the tender/contract:
