

A. PEC Recommendations:

In view of above deliberations, PEC recommends:

A.1 To award the work:

A.1.1 For Subhead-1: To M/s RAJU ALI, VC: 836288 (B-3) for subhead-1 at his quoted amount of Rs. 3,44,85,924.00/-(inclusive of 12% GST), which is “At PAR” on the estimated cost put to tender inclusive of 12% GST.

A.1.2 For Subhead-2: To M/s PRADIP KUMAR DUTTA, VC: 823370 (B-1) for subhead-1 at his quoted amount of Rs.54,87,385.00/-(inclusive of 12% GST), which is “At PAR” on the estimated cost put to tender inclusive of 12% GST.

A.2 To obtain performance security @10% of estimated value of the tender/contract:

A.2.1 For Subhead-1 : Rs. 3,44,85,924.00 X 10% =Rs. 34,48,592.4/- say Rs. 34,48,600.00/- from the B-3 Bidder, M/s RAJU ALI, VC: 836288 (B-3).
