

A. PEC Recommendations:

In view of above deliberations, PEC recommends:

A.1 To award the work:

A.1.1 For Subhead-1: To M/s MONI RAM SAHU, V.C- 826615 (B-1) for subhead-1 at his quoted amount of Rs. 3,06,78,330.00 /-(inclusive of 12% GST), which is “At PAR” on the estimated cost put to tender inclusive of 12% GST.

A.1.2 For Subhead-2: to M/s ADITYA DOWARAH, V.C.- 818764 (B-1) for subhead-1 at his quoted amount of Rs. 64,74,085.00 /-(inclusive of 12% GST), which is “At PAR” on the estimated cost put to tender inclusive of 12% GST.

A.2 To obtain performance security @10% of estimated value of the tender/contract:
