

F. PEC Recommendations:

In view of above deliberations, PEC recommends:

F.1 To award the work to M/s ALOK RAJKONWAR, VC: 870358 (**B-1 bidder**) for “Construction of approach road with side drain, structural passway for pipelines behind the production tank area at CAGGS in RDS area” for an amount of Rs.79,30,846.27/- (inclusive of 18% GST), which is at PAR with estimated cost put to tender (inclusive of 18% GST).

F.2 To obtain performance security @10% of estimated value of the tender/contract i.e. Rs.7,93,090.00/- from M/s ALOK RAJKONWAR, VC: 870358.
