You are directed to deposit **Rs.2,12,330/- (Rupees Two Lakhs Twelve Thousand and Three Hundred and Thirty only)** toward security deposit within 10 days from the date of this letter, failing which, 10% of value of work done will be deducted from the running account bills as security deposit as per condition of Clause No. 1(A) on page no.38 of the Tender Document. The Earnest Money Amount of **Rs.77,223/- (Rupees Seventy Seven Thousand Two Hundred and Twenty Three only)** received online payment through CPP portal along with your tender will be refunded after your depositing of security deposit or after adjustment of the EMD amount as security deposit from the running bills.

6. Please note that the time allowed for carrying out the work shall be **2 (Two) Months** and same shall be reckoned from **Immediate** after issue of this letter

8. Necessary BCAS clearance to execute the work at Airport/Obtaining Security/Entry Passes has to be obtained through e-sahaj portal.
