1. M/s Aroon Aviation Services Pvt Ltd

a. The bidder has submit RC details of Vehicles towards technically eligibility. However, Regn. Validity as mentioned in respective 15 RC'S (Vehicles) had expired and for remaining 15 RC'S Regn. Validity has been mentioned as 'as per fitness'. Therefore, the bidder is requested to submit valid RC'S for all the submitted vehicles depicting therein Regn. Validity as per NIET.

b. The bidder has submitted declaration wherein they have declared current/past contract and subsequently the bidder has submitted No Dues Certificate for all these contracts. However, contract period of Kanpur and Varanasi airports are not matching with the respective NDC'S. Therefore, the bidder is requested to submit correct declaration as per NIET.

c. The bidder has not submitted Anneuxre J. Therefore, the bidder is requested to submit the same as per NIET.

d. The bidder has submitted that they were debarred by Moradabad Railway Division for a period of 02 years vide letter dated 18.08.2020 and Hon'ble High Court had passed an order dated 12.02.2021 vide which there is no bar on the cited bidder in participating in the tenders issued by Railways other Moradabad Division or any other Public Sector Undertakings.

The bidder is requested to submit documentary evidence towards expiry of debarment / Court order, etc depicting therein that the cited bidder is not debarred by any Govt body.

e (i). As per information retrieved from Ministry of Corporate Affairs, there are 03 directors i.r.o M/s Aroon Aviation Services Pvt Ltd and these are as below:-

- Suresh Kumar Rana
- Arun Kumar Rana
- Alka Rani

e (ii). However, the power of attorney read with board resolution submitted by the bidder, the name of third Director is mentioned as Alka Rana. Further as per directors report submitted by the bidder at S.No 13 , the name of 3rd director has been mentioned as Alka Rani and at S.No 17 same is mentioned as Alka Rana. It is also pertinent to mention that at financial statement / Balance sheet also towards name of Holders (shareholders) its mentioned as Alka Rani.

e (iii). As per Annexure F (undertaking) submitted by the bidder, they have declared that the documents provided are true , correct and concealment of facts and giving false information is punishable offence and the agency can be barred and legal action can be taken for the same.

The bidder is requested to clarify the same with supportive documents i.r.o its third Director i.e Alka Rani / Alka Rana and reasons for submitting false / incorrect information

2. M/s GAURAV TOUR & TRAVELS.

a. The Bidder has not submitted documentary evidence towards claiming Technical Eligibility. Therefore, the bidder is requested to submit the same as per NIET.

b. The Bidder has not submitted documentary evidence towards legal status. Therefore, the bidder is requested to submit the same as per NIET.

c. The Bidder has not submitted documentary evidence towards M.A and A.A, Partnership Deed etc. Therefore, the bidder is requested to submit the same as per NIET.

d. The Bidder has not submitted documentary evidence towards payment proof of tender fee and EMD. Therefore, the bidder is requested to submit the same as per NIET.

e. The bidder has submitted Copy of Authorization letter (Power of Attorney) (Annexure B) but same is not as per NIET. Therefore, the bidder is requested to submit the same as per NIET.

f. The Bidder has not submitted documentary evidence towards Certificate from C.A for technical capacity and experience (Annexure E). Therefore, the bidder is requested to submit the same as per NIET.

g. The bidder has not submitted Annexure J. Therefore, the bidder is requested to submit the same as per NIET.

3.M/s Taj India Tours.

- a. The bidder has submit RC details of Vehicles towards technically eligibility. However all these 25 RC'S Regn. Validity has been mentioned as 'as per fitness'. Therefore the bidder is requested to submit valid RC'S for all the submitted vehicles depicting therein Regn. Validity as per NIET.
- b. The bidder has submitted Copy of Certificate from C.A for technical capacity and experience (Annexure E), however same is not as per NIET and Positive Net Worth Certificate has also not been submitted by the bidder. Therefore, the bidder is requested to submit the said document as per NIET.
- c. The bidder has submitted declaration wherein they have declared current/past contract and subsequently the bidder has submitted No Dues Certificate for all these contracts. However, contract period of all the airports are not matching with the respective NDC'S. Therefore, the bidder is requested to submit correct declaration as per NIET.

All the above bidders are requested to submit clarification with supporting documents within 07 days. Submission of clarification / documents in any other mode i.e. through email, fax, by post etc. shall not be considered / entertained.
