Based on the submission of technical bid of different agencies through EV-I, shortfall has been pointed out and accordingly same has been communicated to different bidders through CPP portal on 01.09.2025 with shortfall submission date from 01.09.2025 to 03.09.2025.

Subsequently, based on shortfall documents submission, scrutiny no II has been prepared ([Copy enclosed](#)) and in this regard, the followings are submitted:-

1. M/S 10189 Nicholas Suranjan SA and M/s 9995 Sanjiv Dayal Mathur SA have submitted all the documents in compliance with NIT requirement and are recommended for acceptance of opening of EV- II.
2. It has been observed that, M/s 10064 Rhitwik Lahari SA has submitted Annexure B and Annexure D properly, but uploaded the sealed and signed NIT Copy of M/s 10189 Nicholas Suranjan SA.

As per the AAI standard practice/ policy guidelines invoked, shortfall documents have been sought for maximum of two times in other departments. Keeping this in view, it has been recommended by the committee that submission of shortfall documents may be extended again up to 08.09.2025 within 1200 hours.

Nevertheless, it is pertinent to mention here that according to the DGR guidelines and norms of Sponsorship letter, it has been advised to award the contract only to the Senior Most Security Agency. However, as per the standard practice/norm of AAI, the shortfall documents may be sought from M/s 10064 Rhitwik Lahari SA for the second time.
