

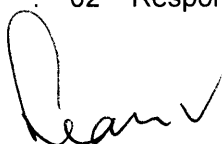

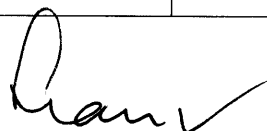

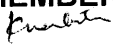
17 **OBSERVATIONS OF CWC-II HELD ON 02-07-2025 :**

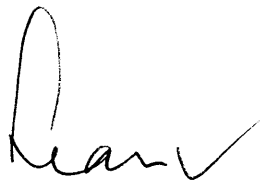
CWC-II deliberated the case and observed that both the participating Contractors have fulfilled the eligibility conditions of the tender.

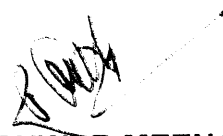
18 **DECISION OF CWC-II HELD ON 02-07-2025**

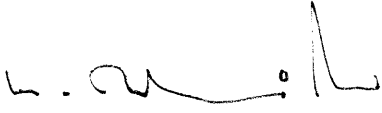
