

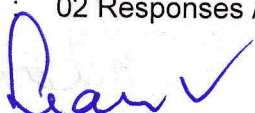

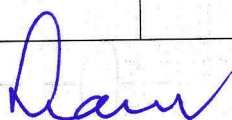

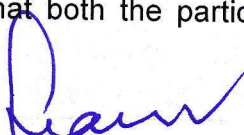

18. OBSERVATIONS OF CWC- I HELD ON 01-08-2025:

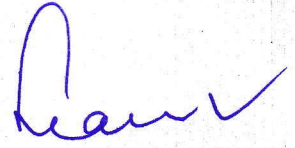
CWC- I deliberated the case and observed that both the participating contractors have fulfilled the eligibility conditions of the tender.

- b) M/s S Vinayagamurthy, Tiruvallur

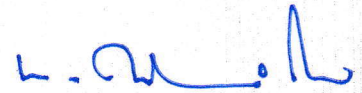
