13	Past tender details	:	In pursuance of CWC Level-I decision vide Minutes dated 08.11.2024 for floating the advance tender enquiry with the direction to process the case up to the stage of CWC Technical Evaluation and price bid shall be opened only after receiving approval from ADP AVNL CO., the tender EFA/EO(C)/1279/E/TE/10/2024-25, Dated: 21.11.2024 was published and was opened on 09.12.2024. AVNLCO vide Lr No. AVNLCO/ENGG/P&M/ADP/EFA/ND2305 dated: 13/01/2025 approved the case to process up to TEC and price bid opening to be done after obtaining approval for additional CAPEX. Meanwhile, ADP approval was accorded vide AVNL Ltr. No. AVNLCO/ENGG/P&M/ADP/EFA(ND2305) DT: 27.06.2025 to process the case further under Modernization fund (902/01). Subsequently, the three responded firms viz. M/s TMS Constructions, Chennai, M/s Danush Interiors & Contractors, Chennai and M/s JDN Construction, Thiruvallur were asked to extend the validity of their respective offers and the EMD validity suitably. In response, M/s TMS Constructions, Chennai vide letter dated 30.06.2025 confirmed for extension of the validity of offer as well as EMD for three months. M/s Danush Interiors & Contractors, Chennai vide e-mail dated 09.07.2025 confirmed the extension of offer up to 31.07.2025 and stated that the validity of EMD was Auto extended and need not to be extended manually. However, M/s JDN Construction, Thiruvallur vide e-mail dated 09.07.2025 expressed their inability to extend the validities as sought by EFA. Subsequently, GM/QC & CP conversed with the firm through telephone on 15.07.2025 for extension of validity of their offer and the EMD. Further, EFA given e-mail to the firm with reference to the conversation with GM/QC & CP. But the firm in response vide e-mail dated 15.07.2025 again regretted to extend the validities sought. In view of the above, CWC Level – I held on 16.07.2025 deliberated the case and observed that only two firms had satisfied the eligibility conditions laid down in the tender. Hence, recommended for retendering the case to have more competitive offers. Accordingly, the case has been retendered vide the current tender.

	CWC Level – I deliberated the case in detail and decided to open the price bids of the following qualified firms submitted against EFA tender EFA/EO(C)/1280/E/TE/17/2025-26 dated 28.07.2025 for “Repairs / Renovation of all Production and Non- Production Toilets including Electrical wiring and fittings at EFA”. 1. M/s. Hari Enterprises 2. M/s TMS Constructions 3. M/s T.Paulkannu & Co 4. M/s Intex Space Solutions Private Limited
