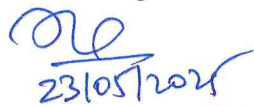

5. DGM/Electrical of this organization will be the Engineer for this contract.

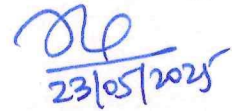
