With reference to above tender (D2EUD/T-14), Letter of Acceptance (LOA) is hereby issued to you for the above mentioned work at the total cost of estimated ₹ 5,54,56,296.20 (Rupees Five Crores Fifty-Four Lakhs Fifty-Six Thousand Two Hundred Ninty-Six and Twenty Paise Only) including all taxes, duties, GST, levies, cess and all other incidental charges required to fulfill the tender conditions including statutory deductions viz. TDS towards income tax/GST/labour cess etc.
2. This letter of acceptance is being sent to you in duplicate. You are requested to return one copy of it duly signed by you on all pages indicating "Unconditional Acceptance" thereof so as to reach the undersigned within one week of the receipt of this letter.
3. Shutdown & Coordination with concerned utility owning agencies like BRPL, TPDDL, DTL, NHAI, PWD, MCD, DDA, BSNL, GAIL, MTNL, IGL, Municipal Corporation, forest department, Irrigation & Flood Control, Gas agencies, road traffic department, Delhi Police, Electrical Inspector to the Govt., other DMRC civil contractors for Land & tree cutting, drainage, sewerage & water supply agency, etc. shall be responsibility of the Contractor at his own risk & cost. Further, the contractor shall also be required to interface closely for approvals or permissions as required for the timely & proper execution of the works and also as per the statutory requirements, including timely handing over the works to owning agencies, at his own cost.

4. You shall ensure full compliance with Tax and Labour Laws of India with regard to this contract and shall be solely responsible for the same. You shall keep the employer fully indemnified against any liability of tax, interest, penalty, PF, ESI etc. related matters, even which may subsequently arise.
5. Contractor shall be responsible fully for safety of men, material and all his staff as per latest applicable IE Rules, DMRC SHE manual, and to adhere all terms and conditions of tender documents.
6. Contractor shall have to remove the waste material clean & restore the site immediately after finishing its work and maintain the house keeping during the execution of the work and comply with **CAQM guidelines and rules**.
7. This Letter of Acceptance shall be treated as '**NOTICE TO PROCEED**' as defined in Clause 8.1 of GCC and the work shall be completed within **24 MONTHS (Twenty Four Months)** from the very next day of receipt of LOA.
8. Sr. General Manager/Electrical/UD of this organization will be the '**Engineer**' for this contract.
9. You are requested to contact AGM/Elect./UD immediately for further necessary action in this matter and to start the work.
10. It may please be noted that until a formal agreement is executed, this letter will constitute a binding Contract between you and DMRC. Please take necessary action as required vide Clause **F4** and **F5** of Instructions of Tenderers (ITT) regarding signing of agreement and submission of Performance Security & Insurances, GST, Electrical Licence, EPF/ESI, Joint Venture registration etc. as required under mandatory obligation at the earliest.
11. You are requested to register yourself with DMRC vendor payment portal (**VPP**) for payments etc. as per procedure annexed as **Annexure-A**.
