4. Contractor shall provide tax invoice as per GST Act for releasing payments time to time and charged GST amount in invoice is required to be reflected on GST portal under GSTR-2B. Contractor shall ensure timely GST return filling and other tax compliances.
5. Contractor shall adhere to the Terms and conditions of the Contract as mentioned in Tender document and strictly ensure the payment of wages as per applicable laws.
6. DGM/Electrical/MML-3 of this organization will be the Engineer-In-Charge for this contract so you are requested to contact DGM/Electrical/MML-3 immediately for further necessary action in this matter.
7. You are requested to submit the Performance Security as per clause F5 of ITT.
8. All the work shall be executed in accordance with the specification stipulated in Tender.
9. It may please be noted that until a formal agreement is executed, this letter will constitute a binding Contract between you and DMRC. A Valid Electrical Contractor Licence must be submitted before the signing of the agreement. Please take necessary action as required vide Clause Nos.
