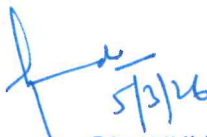

5. JGM/Tele/O&M of this organization will be the Engineer for this contract.

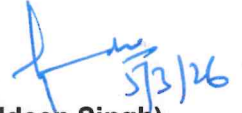
