2.7 REASON OF REJECTION OF NOT ACCEPTABLE BIDDERS:

M/s. AANYA CONTRUCTION AND INFRA ESTATES:

Bidder has uploaded Letter of Acceptance (LoA) No.: 09/DL/2022-23 Dated 07.12.2022 along with its completion certificate which is neither attested by Notary public legible stamp nor certified by Chartered Engineer. However, it is also observed that executed values are not mentioned and also asked to submit the scope of work and SOR for the same. Hence, query was raised to the bidder and bidder was not responded to the query.

Therefore, the bid is not acceptable Technically on the grounds of non-compliance to BEC of the tender document.

M/s. M.L AGRAWAL CONSTRUCTION:

Bidder has not submitted EMD, rather sought exemption under MSE category, however, exemption of EMD under MSE category is not applicable in the instant tender.

Bidder has uploaded multiple Letter of Acceptance (LoA) No.: 5300029137 Dated 13.07.2028 and 5300036854 Dated 30.05.2022 along with its completion certificate which is neither attested by Notary public legible stamp nor certified by Chartered Engineer.

Therefore, Bidder is Not eligible for the EMD exemption and thus, the Offer submitted by the bidder is ***Not Acceptable*** on the grounds of non-submission of EMD and BEC of the tender document.

M/s. MANVI TRADERS:

Bidder has uploaded project work orders: 173/157307 and 173/145373 along with its completion certificate which is neither attested by Notary public legible stamp nor certified by Chartered Engineer. However, it is also observed that executed values for civil construction works are not mentioned in line with BEC requirement and also not uploaded the scope of work and SOR for the same.

Bidder has not submitted EMD, rather sought exemption under MSE category, however, exemption of EMD under MSE category is not applicable in the instant tender.

Therefore, Bidder is Not eligible for the EMD exemption and thus, the Offer submitted by the bidder is ***Not Acceptable*** on the grounds of non-submission of EMD and BEC of the tender document.

M/s. PRIMUS LOGISTICS PRIVATE LIMITED:

The bidder has submitted a DPIIT Certificate No.: DIPP191837 Dated 11.02.2025 that states their registered sector as “New Age *Construction Technologies*” against the requirement of the registered Sector as “*Construction and Engineering*” as mentioned in the Tender Document. As a result, the Bidder does not qualify for any relaxation in the prior experience and prior turnover requirement mentioned in the Bid Evaluation Criteria (BEC).

As per Buyer Added Bid Specific ATC Document, Bidder has to upload the signed and sealed copy of Section-V (Special Conditions of Contract), Section-VI (Scope of Work) as an Acceptance. However, it is observed that the Bidder has not uploaded the aforementioned documents.

Therefore, the Offer submitted by the Bidder is rejected without any further queries on the grounds of non-compliance to BEC of the tender document.

M/s. SHREE SHYAM CONSTRUCTION:

As per Buyer Added Bid Specific ATC document, Section-II Clause No.: 14 of BEC Notes, “*Only documents (Purchase Order, Completion certificate, Execution Certificate etc.) which have been referred/ specified in the bid shall be considered in reply to queries during evaluation of Bids. After submission of bid, only related shortfall documents will be asked for in TQ/CQ and considered for evaluation*”. It was observed that the bidder has not uploaded any relevant Purchase Order/ Work Order related to Technical BEC. Hence, the offer submitted by the bidder is Not Acceptable Technically.

Therefore, the Offer submitted by the Bidder is not acceptable without any further queries on the grounds of non-compliance to BEC of the tender document.

M/s. JYOTI REAL INFRA PRIVATE LIMITED:

The bidder has uploaded a DPIIT Certificate No.: DIPPI124658 Dated 05.03.2023 which states their registered sector and industry is same as mentioned in the tender document. As startup bidder is exempted to prior experience and prior annual turnover. However, The bidder's working capital as per Form F-10 (INR 64,416.00 for FY 2023-2024) was found to be inadequate. Additionally, the bidder failed to submit a line of credit for the required working capital amount specified in the tender before final bid due date, hence bid is rejected commercially due to non-compliance with the Financial BEC.

Therefore, the bid is not acceptable Commercially on the grounds of non-compliance to BEC of the tender document.

2.8 The techno-commercially acceptable bidder names are not appearing in Holiday/Banning/Suspension list of vendors available in GAIL Intranet as on date i.e., 29.08.2025.
