

2.3 **REASON OF REJECTION:**

1. **M/S. HMKMULTI INFRA (OPC) PVT. LTD.**

- a) Bidder working capital is not sufficient to Qualify BEC Criteria and also bidder has not submitted line of credit. Therefore bid is not acceptable.

2. **M/S. SHREE SHYAM CONSTRUCTION**

- a) The bidder has submitted Startup Certificate : DIPP211806 but neither it is Notarized by Notary Public nor certified by Chartered Accountant.
- b) Bidder has Not Uploaded duly Noterized audited financial statement of FY2022-23, FY 2023-24, FY2024-25.
- c) Bidder has Not Uploaded following forms & Formats
 - i. F-10: Format For Chartered Accountant Certificate/ Certified Public Accountant (CPA) For Financial Capability Of The Bidder,
 - ii. Format F-14: Integrity Pact, Power Of Attorney & Name Of Person,
 - iii. F-17: Undertaking Regarding Submission Of Electronic Invoice (E-Invoice As Per GST Laws),
 - iv. Form: 2 -Self Certification By Bidder Who Class-I /Class-II Local Supplier.

Above documents are not submitted even after query, therefore rejected.

3. **M/S. GILL CONSTRUCTION**

- a) The bidder has submitted AMC related experience which is not acceptable as per BEC.
- b) Bidder has Uploaded audited financial statement of FY2023-24 but it is not duly Noterized & bidder has not uploaded audited financial statement of FY 2022-23.
- c) Bidder has Not Uploaded following forms & Formats
 - i. Form-I-B: Undertaking On Letterhead (Applicable In Case Of Transfer Of Technology Cases Only),
 - ii. Form-II: Certificate For Tenders For Works Involving Possibility Of Sub-Contracting, Form:2 -Self Certification By Bidder Who Class-I /Class-II Local Supplier ,

Since bidder is rejected in TBA, therefore no query raised.

4. **M/S. DEETYA INFRA PROJECTS AND DEVELOPERS PVT. LTD.**

- a) Bidder has Not Uploaded duly Noterized copy of audited financial statement of FY2022-23, FY 2023-24, FY2024-25.
- b) Bidder has not Not Uploaded following forms & Formats
 - i. F-10 :Format For Chartered Accountant Certificate/ Certified Public Accountant (CPA) For Financial Capability Of The Bidder,
 - ii. Format F-14: Integrity Pact,
 - iii. Form:2 -Self Certification By Bidder Who Class-I /Class-II Local Supplier

Above documents are not submitted even after query, therefore rejected.

5. **M/S. GKR BUILDDEV PVT. LTD.**

Working capital of Rs. 15.02 Lakhs of bidder is not sufficient to qualify BEC criteria of 25 Lakhs, Line of credit is also not submitted. Therefore rejected.

6. **M/S. BYMA CONSTRUCTIONS PVT. LTD.**

Bidder's working capital is not sufficient to qualify BEC, bidder has also not Uploaded F-9 line of credit in Bank's letterhead.

7. **M/S. RJSHAKTI CONSTRUCTION PRIVATE**

- a) Bidder has not submitted Notarized copy of audited balance sheet of FY2021-22, FY2022-23 & FY2023-24.
- b) Working capital of Rs. 10.09 Lakhs of bidder is not sufficient to qualify BEC criteria of 25 Lakhs, Line of credit is also not submitted. Therefore rejected.

8. **M/S. OCTILLIYARD PVT. LTD.**
