

Recommendation of TEC on Evaluation of Technical Bids for Online Tender of "Supply of Transducers for Multi Beam Echo-Sounder (Bathyswath Bathymetric System)"

1. Online bids were called by IWAI by publishing NIT in leading newspapers, IWAI and CPP Portal websites for "Supply of Transducers for Multi Beam Echo-Sounder (Bathyswath Bathymetric System)". In response to the NIT, one no. bidder has submitted their online bid before the stipulated last date, 11.03.2025 at 1500 hrs. The details of the bidder who submitted the bid is as follows:

(a) M/s SPRY Technocon Pvt. Ltd., Corporate 1814-B, 18th Floor, Global Magnum Park, Sector 58, Gurgaon, Haryana – 122101.

2. The duly constituted Tender Evaluation Committee (TEC) comprising of the following officers have evaluated the online technical bids:

- i. Sh. Rakesh Kumar, Dir. (Hy.)
- ii. Sh. Ajoy Kar, DD Fin.
- iii. Shri Sonu Singhal, A.H.S.

3. Tender Evaluation Committee (TEC) examined the technical bid with respect to the terms and conditions and Technical & Special conditions stipulated in the tender document.
4. Accordingly, the technical bids have been evaluated and comparative statement prepared is placed at Annex-1, 2, & 3.
5. Further, in the Manual for Procurement of Goods Second Edition, 2024 and GFR-2017, Rule 166 (i) lays down that procurement from a single source may be resorted to in the following circumstance-

In the procurement of goods, certain items are procured only from Original Equipment Manufacturers (OEMs) or manufacturers having proprietary rights (or their authorised dealers/stockists) against a PAC certificate (Annexure 9).

"It is in the knowledge of the user department that only a particular firm is the manufacturer of the required goods."

6. In this regard, it is submitted that, after obtaining the approval of the Competent Authority (the details of which are also to be filled in the PAC), this PAC will be



furnished by the Hydrography wing before the procurement from a single source/ bidder.

7. TEC further observed that wide publicity was given and the tender has been called for 2nd time, yet only single bid has been received. These Hydrographic Survey equipment are very specialized systems which are used by mariners for precise navigation. These requires expertise, after sale support and financial capability and hence availability of such firms is very limited in India. Transducers for Multi Beam Echo-Sounder are being supplied by M/s SPRY Technocon Pvt. Ltd. and OEM (M/s ITER Systems, France) has certified that the bidder is exclusive authorized distributor in India for all **Bathyswath Bathymetric System** (Multi Beam Echo-Sounder) and related maintenance plan and all hardware systems and M/s ITER Systems further declared that only M/s SPRY Technocon Pvt. Ltd is specifically authorized to submit a bid for **Bathyswath Bathymetric System** (Multi Beam Echo-Sounder) in response to this tender.

TEC Recommendations: In view of the above, the TEC recommended to technically qualify the single bidder, i.e. M/s SPRY Technocon Pvt. Ltd., Gurgaon, Haryana and to open their financial bid.
