The payment of monthly bills shall be made as per terms and conditions of the contract and as per BOQ. However, payment of GST as applicable shall be considered as per rule.

3. It is inform that deploy your security guards within 3 days at above RIS stations as per Annexure and provide the complete safety and security. However, submit their Bio-data, Photograph, Address Proof, Photo copy of Adhar Card etc. to this office for necessary action at our end.

You are also requested to kindly acknowledge the receipt of this letter as token of acceptance and attend the office of the Director, IWAI, RO, Varanasi along with two non-judicial stamp papers of Rs. 1000.00 (Rupees One thousand only) each to enter into Formal agreement and Integrity agreement within 15 days from the date of issue of this work order.

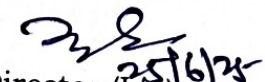
