(4) Observation of TEC:

(a) M/s GHOSH ENTERPRISE

On scrutiny after opening of the financial bid of technically qualified bidder M/s GHOSH ENTERPRISE based on the comparative statement it is observed that M/s GHOSH ENTERPRISE (L-1) has quoted Rs. 14,32,093.89/- say Rs. 14,32,094.00/- which is lower (- 4.61%) then the estimated cost.

(b) M/s RUPNARAYAN MARINE WORKS

On scrutiny after opening of the financial bid of technically qualified bidder M/s RUPNARAYAN MARINE WORKS based on the comparative statement it is observed that M/s RUPNARAYAN MARINE WORKS (L-2) has quoted Rs. 15,01,153.87/- say Rs. 15,01,154.00/- which is lower (- 0.01%) then the estimated cost.

(5) TEC Recommendation:

R.O. Kolkata TEC, scrutinized the bids of two technically qualified bidder and observed that M/s Ghosh Enterprise is L-1 bidder has quoted Rs. 14,32,093.89/- say Rs. 14,32,094.00/- plus GST and cost of spare on actual plus 10% basis which is lower (- 4.61%) then estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e., M/s Ghosh Enterprise at the quoted price of Rs. 14,32,094.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of Competent Authority.
