(4) Observation of TEC:

(a) M/S Allied Technologies

On scrutiny it is observed that M/S Allied Technologies, has submitted the relevant documents for qualified technically except,

- 1) Tender Acceptance letter with date.
- 2) Form of tender with date.
- 3) Solvency certificate duly signed and stamped.
- 4) Work completion duly signed and stamped.
- 5) GST Registration duly signed and stamped.
- 6) PAN details copy.
- 7) Audited balance sheet duly signed and stamped.
- 8) Last 3-year ITR duly signed and stamped.
- 9) Ban De-listing declaration.
- 10) No-Litigation declaration.
- 11) Dry-dock land details.

As per TEC's opinion the shortfall documents were asked to M/S Allied Technologies on dated 13.06.2025 through online e-procurement site. As the bidder M/S Allied Technologies did not reply in shortfall documents therefore, **the firm may not be considered technically qualified.**

(b) **M/s GHOSH ENTERPRISE**

On scrutiny it is observed that M/s GHOSH ENTERPRISE, has submitted the relevant documents for qualified technically except,

- 1) Banned & De-listed declaration duly signed and stamped.
- 2) Income Tax Return FY 2021-22 duly signed and stamped.
- 3) Valid Firm registration certificate duly signed and stamped.

As per TEC's opinion the shortfall documents were asked to M/s GHOSH ENTERPRISE on dated 13.06.2025 through online e-procurement site. As the bidder M/s GHOSH ENTERPRISE has submitted the required document in shortfall documents therefore, **the firm may be considered technically qualified.**

(c) **M/s RUPNARAYAN MARINE WORKS**

On scrutiny it is observed that M/s RUPNARAYAN MARINE WORKS, has submitted the relevant documents for qualified technically except,

- 5) ITR FY 2022-23, 2023-24 duly signed and stamped.

As per TEC's opinion the shortfall documents were asked to M/s RUPNARAYAN MARINE WORKS on dated 13.06.2025 through online e-procurement site. As the bidder M/s RUPNARAYAN MARINE WORKS has submitted the required document in shortfall documents therefore, **the firm may be considered technically qualified**

(5) **TEC Recommendation:**

As per TEC opinion shortfall were asked from the above three bidders for above-mentioned documents and the same were to be submitted in online CPP portal on or before 13.06.2025. up to 12:00 hrs. After opened the shortfall TEC observed that among the three bidders, M/S Allied Technology did not reply for the shortfall and M/s Ghosh Enterprise & M/s Rupnarayan Marine Works has submitted the required shortfall documents. On scrutiny it is observed that two bidder M/s Ghosh Enterprise & M/s Rupnarayan Marine Works qualified technically.

Hence the TEC recommends opening the financial bids of the two technically qualified bidders i.e. M/s GHOSH ENTERPRISE and M/s Rupnarayan Marine Works.
