

RECOMMENDATION OF TEC FOR DRY DOCK REPAIR OF IWAI VESSEL CPB II & CPB IV AT GUWAHATI (NW-2) FOR THE YEAR 2025-26

NIT for Dry dock repair of CPB II and CPB IV at Guwahati (NW-2) for the year 2025-26 was published on 26th May 2025 on IWAI website and e-procurement portal. In response to the NIT, following five parties submitted their bids on the scheduled date and time i.e., 10th June 2025 at 1130 hrs, which is the last date of submission of the offers:

3. M/s Das Consultancy & Agency Services, Guwahati. (3/5)

5. M/s Shriji Offshore Services Pvt. Ltd., Maharashtra (5/5)

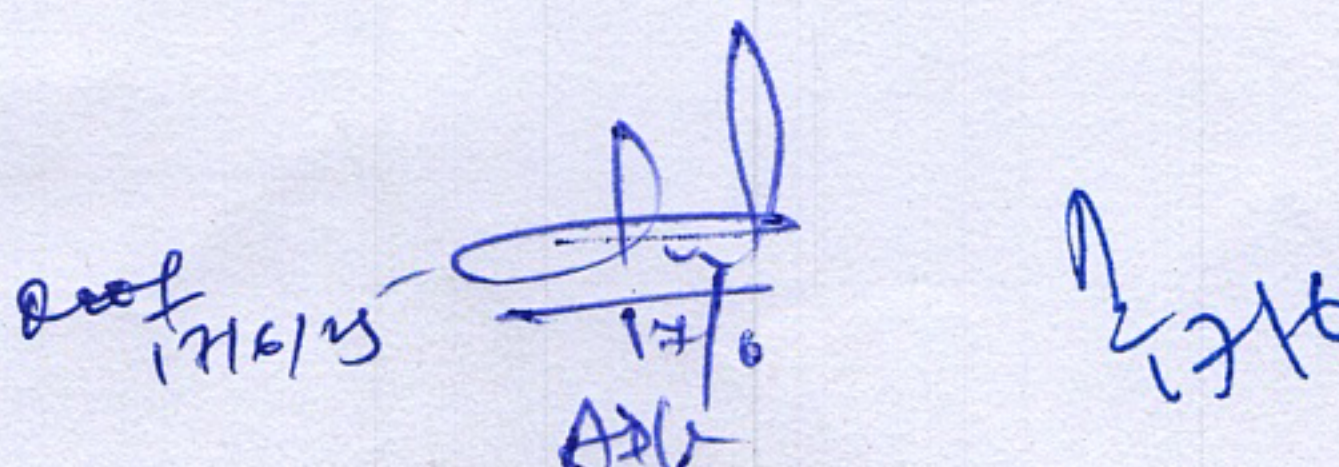
Accordingly, a technical comparative statement has been prepared and enclosed as Annex-1.

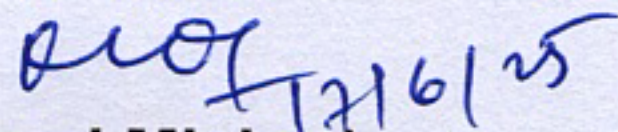
In response, out of above 5 (five) nos. bidders, the following bidders had submitted the shortfall documents as on scheduled date and time.

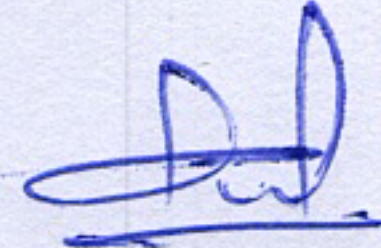
1. M/s Rishansh Marine Solutions LLP, Maharashtra. (1/5)
 - Submitted Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or Public sector undertaking, PSU.
 - Submitted Last 3 years Annual Turnover Certificate with Seal and Sign of CA and with UDIN no.
2. M/s Om Shiv Sai Enterprises, Mumbai. (4/5)
 - Scanned copy of registration of the firm/business entity from concerned authority.
 - Submitted Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or Public sector undertaking, PSU.
 - Submitted ESIC & EPFO registration certificate
3. M/s Shriji Offshore Services Pvt. Ltd., Maharashtra (5/5)
 - Submitted Scanned copy of tender document duly signed and stamped
 - Submitted copy of registration of the firm/ business entity from concerned authority
 - Submitted work experience is not illegible for the required work.
 - Submitted Undertaking towards Registration with Major Port of India as the firm is not registered currently under any Major Port Trust of India.
 - Submitted undertaking towards ESIC & EPFO registration that the firm is not registered under ESIC & EPFO. Therefore, the firm is technically disqualified.

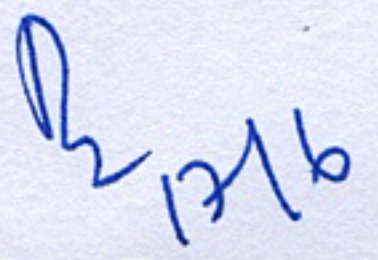

Accordingly, after examining the shortfall documents submitted by above 3 (three) nos. bidders, TEC recommends that M/s Rishansh Marine Solutions LLP, Maharashtra (1/5) and M/s Om Shiv Sai Enterprises, Mumbai (4/5) are found technically qualified and accordingly it is recommended that the financial bids of the 2 (two) nos. technically qualified bidders may be opened.
