(4) Observation of TEC:

(a) M/s Madheshiya Marines

On scrutiny it is observed that M/s Madheshiya Marines, has submitted the relevant documents for qualified technically except,

- 1) Tender acceptance letter duly signed and stamped.
- 2) Form of tender duly signed and stamped.
- 3) Solvency certificate duly signed and stamped.
- 4) Work completion certificate duly signed and stamped.
- 5) No alteration declaration duly signed and stamped as per tender clause: tech. bid, sl. no. (p), page no. 13.
- 6) Bank account detail along with cancel cheque duly signed and stamped.
- 7) Last three-year ITR file duly signed and stamped.
- 8) Updated banned or delisted duly signed and stamped as per tender clause no. 12, sr. no. (x), page no. 7.
- 9) Land details and no litigation declaration duly signed and stamped as per tender clause no. 12, sr. no. (xi), page no. 8.
- 10) Certificate Registered with any major port of India, MES, IWT wing of Indian army, BSF or any other central Govt. Dept or experience of working with IWAI with similar work, as per tender clause: 12, sr. no. (ii), page no. 7.
- 11) The average annual financial turnover during last three years ending 31st march as per tender clause no. 12, sr. no. (vi), page no. 7.

(b) **M/s GHOSH ENTERPRISE**

On scrutiny it is observed that M/s MILAN MARINE SERVICE, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, Solvency certificate, Work completion certificate etc. Therefore, the firm may be considered technically qualified.

Hence, considering above, TEC recommends that to obtain shortfall from M/S Madheshiya Marines as mentioned above and the same to be submitted in online CPP portal on or before 07.07.2025 up to 12:00 hrs. After submission of shortfall document by the bidder TEC will finalize the recommendation.
